MESSAGES FROM THE GOVERNOR

Dear President Ellsworth and Speaker Regier:

During this legislative session, we have successfully worked together to bring more innovation to education, expanding opportunities in personalized and work-based learning for Montana students.

As we continue working toward increasing innovation in education, I thank Representative Anderson for his thoughtful efforts with House Bill 458 to get career coaches into more schools to support students in their educational and career endeavors. Career coaches help students obtain valuable, insightful experiences through internships, apprenticeships, and other work-based learning opportunities.

House Bill 458 provides a definition for career coaches, including required education or work experience for school districts to hire them. House Bill 458 provides clarity for districts that a career coach does not have to be a licensed school counselor or educator.

I appreciate the intent of the bill. As currently written, however, the legislation can be improved to prevent an increase in regulations and red tape that will unnecessarily saddle school districts.

Therefore, in accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby **return with amendments House Bill 458**: "AN ACT REVISING LAWS RELATED TO CAREER COACHES; PROVIDING A DEFINITION OF CAREER COACH; PROVIDING FOR DUTIES AND QUALIFICATIONS FOR A CAREER COACH; AND AMENDING SECTION 20-1-101, MCA."

As currently written, House Bill 458 requires the Office of Public Instruction to certify career coaches, an obstacle that does not exist under current law. A new state certification requirement will create red tape and hurdles for districts seeking to hire career coaches.

The amendment I offer proposes striking references to certification while maintaining the overall substance and intent of the bill.

For this reason, I respectfully ask for your support of this amendment.

I appreciate the sponsor's work on House Bill 458 and his support of the amendments I offer.

Amending House Bill 458 will eliminate unnecessary red tape for our school districts and ensure districts can get career coaches more quickly and efficiently into our schools to better prepare our students for their future.

Dear President Ellsworth and Speaker Regier:

A well-negotiated compromise among stakeholders, House Bill 635 brings together those who enjoy the benefits of elk habitat and those who provide and protect elk habitat.

I appreciate Representative Kassmier for successfully leading the charge to move this measure through the Legislature, and I am grateful for the intent of House Bill 635. The bill can be improved by making a minor adjustment to the number of licenses provided to qualifying landowners and by streamlining the implementation and administrative processes for the Department of Fish, Wildlife and Parks so the agency may provide Montanans with more efficient, effective services.

Therefore, in accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby **return with amendments House Bill 635**: "A BILL FOR AN ACT ESTABLISHING A LANDOWNER PREFERENCE POOL FOR CLASS B-10 NONRESIDENT BIG GAME COMBINATION LICENSES; ALLOWING PURCHASE OF AN ADDITIONAL BONUS POINT FOR CERTAIN NONRESIDENT LANDOWNERS; PROVIDING RULEMAKING AUTHORITY; AMENDING SECTION 87-2-115, MCA; AND PROVIDING A DELAYED EFFECTIVE DATE."

As currently written, House Bill 635 requires a landowner to own at least 2,500 contiguous acres in fee title to qualify for the preference pool. It also further provides that for each additional 2,500 contiguous acres, a landowner may receive an additional license, up to a maximum of five licenses.

One of the amendments I offer simplifies the bill by doing away with the need for an assessment of graduated acres and licenses. Instead, it establishes the simple maximum threshold of three licenses for any landowner owning at least 2,500 acres.

Another amendment I offer requires a qualifying landowner to have owned the subject property for at least three years.

I appreciate the sponsor's support of the modest amendments I offer, and I respectfully ask for your support.
