11	ENVIRONMENT, AND NATURAL HAZARDS WHEN DEVELOPING A LAND USE PLAN, MAP, AND ZONING
12	REGULATION; PROVIDING FOR A PROCEDURE TO REVIEW SUBDIVISIONS AND APPROVE FINAL
13	PLATS; PROVIDING FOR A LOCAL GOVERNING BODY TO COLLECT FEES; PROVIDING AN APPEALS

18	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

20	NEW SECTION. Section 1. Short Title. [Sections 1 through 37] may be cited as the "Montana Land
21	Use Planning Act".
22	
23	NEW SECTION. Section 2. Legislative purpose, findings, and intent. (1) It is the purpose of
24	[sections 1 through 37] to promote the health, safety, and welfare of the people of Montana through a system of
25	comprehensive planning that balances private property rights and values, economic efficiency in public services
26	and infrastructure, protection of the environment, natural resources, and recreation, and a diversified and

- sustainable economy.

(2) The legislature finds that coordinated and planned growth within cities and counties will



1	encourage, support, and protect:		
2	(a)	sufficient housing units for the state's growing population that are attainable for citizens of all	
3	income levels;		
4	(b)	the provision of adequate public services and infrastructure in the most cost-effective manner	
5	possible, share	ed equitably among all residents, businesses, and industries;	
6	(C)	the natural environment, including wildlife and wildlife habitat, sufficient and clean water, and	
7	healthy air qua	ality;	
8	(d)	agricultural, forestry, and mining lands for the production of food, fiber, and minerals and their	
9	economic ben	efits;	
10	(e)	the state's economy and tax base through job creation, business development, and the	
11	revitalization o	f established communities;	
12	(f)	persons, property, infrastructure, and the economy against natural hazards, such as flooding,	
13	earthquake, w	ildfire, and drought; and	
14	(g)	local consideration, participation, and review of plans for projected population changes and	
15	impacts resulti	ing from those plans.	
16	(3)	It is the legislature's intent that the comprehensive planning authorized in [sections 1 through	
17	37]:		
18	(a)	provides the broadest and most comprehensive level of collecting data, identifying and	
19	analyzing exis	ting conditions and future opportunities and constraints, acknowledging and addressing the	
20	impacts of dev	relopment on each jurisdiction, and providing for broad public participation;	
21	(b)	serves as the basis for implementing specific land use regulations that are in substantial	
22	compliance wi	th the local land use plan;	
23	(C)	provides for local government approval of development proposals in substantial compliance	
24	with the land u	se plan, based on information, analysis, and public participation provided during the development	
25	and adoption of	of the land use plan and implementing regulations; and	
26	(d)	allows for streamlined administrative review decisionmaking for site-specific development	
27	applications.

1	NEW SECTION. Section 3. Definitions. As used in [sections 1 through 37], unless the context or	
2	subject matter clearly requires otherwise, the following definitions apply:	
3	(1) "Aggrieved party" means a person who can demonstrate a specific personal and legal interest,	
4	as distinguished from a general interest, who has been or is likely to be specially and injuriously affected by the	
5	decision.	
6	(2) "Applicant" means a person who seeks a land use permit or other approval of a development	
7	proposal.	
8	(3) "Built environment" means man-made or modified structures that provide people with living,	
9	working, and recreational spaces.	
10	(4) "Cash-in-lieu donation" is the amount equal to the fair market value of unsubdivided,	
11	unimproved land.	
12	(5) "Certificate of survey" means a drawing of a field survey prepared by a registered surveyor for	
13	the purpose of disclosing facts pertaining to boundary locations.	
14	(6) "Dedication" means the deliberate appropriation of land by an owner for any general and public	
15	use, reserving to the landowner no rights that are incompatible with the full exercise and enjoyment of the	
16	public use to which the property has been devoted.	
17	(7) "Division of land" means the segregation of one or more parcels of land from a larger tract held	
18	in single or undivided ownership by transferring or contracting to transfer title to a portion of the tract or properly	
19	filing a certificate of survey or subdivision plat establishing the identity of the segregated parcels pursuant to	
20	[sections 1 through 37]. The conveyance of a tract of record or an entire parcel of land that was created by a	
21	previous division of land is not a division of land.	
22	(8) "Dwelling unit" means a residential structure in which a person or persons reside.	
23	(9) "Examining land surveyor" means a registered land surveyor appointed by the governing body	
24	to review surveys and plats submitted for filing.	
25	(10) "Final plat" means the final drawing of the subdivision and dedication required by [sections 1	
26	through 37] to be prepared for filing for record with the county clerk and recorder and containing all elements	
27	and requirements set forth in [sections 1 through 37] and in regulations adopted pursuant to [sections 1 through	
28	37].

1 (11) "Land use permit" means an authorization to complete development in conformance with an

2 application approved by the local government.

3 (12) "Land use plan" means the land use plan and future land use map adopted in accordance with
4 [sections 1 through 37].

5 (13) "Land use regulations" means zoning, zoning map, subdivision, or other land use regulations
6 authorized by state law.

7 (14) "Local governing body" or "governing body" means the elected body responsible for the
8 administration of a local government.

9 (15) "Local government" means a county, consolidated city-county, or an incorporated municipality
10 to which the provisions of [sections 1 through 37] apply.

11 (16) "Manufactured housing" means a dwelling for a single household, built offsite in a factory on or

12 after January 1, 1990, that is placed on a permanent foundation, is at least 1,000 square feet in size, has a

13 pitched roof and siding and roofing materials that are customarily, as defined by local regulations, used on site-

built homes, and is in compliance with the applicable prevailing standards of the United States department of

15 housing and urban development at the time of its production. A manufactured home does not include a mobile

16 home or housetrailer, as defined in 15-1-101.

17 (17) "Ministerial permit" means a permit granted upon a determination that a proposed project
18 complies with the zoning map and the established standards set forth in the zoning regulations. The

19 determination must be based on objective standards, involving little or no personal judgment, and must be

20 issued by the planning administrator.

(18) "Planning administrator" means the person designated by the local governing body to review,
analyze, provide recommendations, or make final decisions on any or all zoning, subdivision, and other
development applications as required in [sections 1 through 37].

(19) "Plat" means a graphical representation of a subdivision showing the division of land into lots,
parcels, blocks, streets, alleys, and other divisions and dedications.

(20) "Preliminary plat" means a neat and scaled drawing of a proposed subdivision showing the
layout of streets, alleys, lots, blocks, and other elements of a subdivision that furnish a basis for review by a
governing body.

15	(25)	"Tract of record" means an individual parcel of land, irrespective of ownership, that can be
16	identified by leg	al description, independent of any other parcel of land, using documents on file in the records of
17	the county clerk	k and recorder's office.

19	NEW S	ECTION. Section 4. Planning commission. (1) (a) Each local government shall establish, by
20	ordinance or re	solution, a planning commission.
21	(b)	Any combination of local governments may create a multi-jurisdiction planning commission or
22	join an existing	commission pursuant to an interlocal agreement.
23	(C)	(i) Any combination of legally authorized planning boards, zoning commissions, planning and
24	zoning commis	sions, or boards of adjustment existing prior to [the effective date of this act] may be considered
25	duly constituted	under [sections 1 through 37] as a planning commission by agreement of the governing bodies
26	of each jurisdic	tion represented on the planning commission.
27	(ii)	If more than one legally authorized planning board, zoning commission, or planning and zoning
28	commission exi	ists within a jurisdiction, the governing bodies of each jurisdiction may agree to:

9 (b) The planning commission shall meet at least once every 6 months.

10 (c) Minutes must be kept of all meetings of the planning commission and all meetings and records
11 must be open to the public.

(d) A majority of currently appointed voting members of the planning commission constitutes a
 quorum. A quorum must be present for the planning commission to take official action. A favorable vote of at
 least a majority of the quorum is required to authorize an action at a regular or properly called special meeting.

(e) The ordinance, resolution, or interlocal agreement creating the planning commission must set
forth the requirements for appointments, terms, qualifications, removal, vacancies, meetings, notice of
meetings, officers, reimbursement of costs, bylaws, or any other requirement determined necessary by the local
governing body.

(3) (a) Except as set forth in subsection (3)(b), the planning commission shall review and make
 recommendations to the local governing body regarding the development, adoption, amendment, review, and
 approval or denial of the following documents:

22 (i) the land use plan and future land use map as provided in [section 7];

23 (ii) zoning regulations and map as provided in [sections 18 through 24];

24 (iii) subdivision regulations as provided in [sections 25 through 33]; and

25 (iv) any other legislative land use planning document the local governing body designates.

26 (b) In accordance with [section 36], the planning commission shall hear and decide appeals from 27 any site-specific land use decisions made by the planning administrator pursuant to the adopted regulations

described in subsection (3)(a). Decisions of the planning commission may be appealed to the local governing

 exceeding 70,000 in the most recent decennial census shall comply with the provisions of [sections 1 through
 37].

7 (2) A municipality within a county identified in subsection (1) with a population at or exceeding
5,000 in the most recent decennial census shall comply with the provisions of [sections 1 through 37].

9 (3) (a) Except as provided in subsection (3)(b), any local government that meets the population 10 thresholds of subsections (1) or (2) on [the effective date of this act] shall comply with the provisions of 11 [sections 1 through 37] within 3 years of [the effective date of this act].

12 (b) A local government that has adopted a growth policy within 5 years prior to [the effective date 13 of this act] shall comply with the provisions of [sections 1 through 37] within 5 years of the date that the growth 14 policy was adopted or within the deadline established in subsection (3)(a), whichever occurs later.

(c) A local government that meets the population thresholds of subsections (1) or (2) on any
decennial census completed after [the effective date of this act] shall comply with the provisions of [sections 1
through 37] by December 31 of the fifth year after the date of the decennial census.

(4) (a) A local government that does not meet the population thresholds set forth in subsections (1)
or (2) may decide to comply with the provisions of [sections 1 through 37] by an affirmative vote of the local
governing body. After an affirmative vote, the governing body shall comply with the provisions of [sections 1
through 37] by December 31 of the fifth year after the date of the vote.

(b) A local government that votes pursuant to subsection (4)(a) to comply with the provisions of
[sections 1 through 37] may subsequently decide to not comply with the provisions of [sections 1 through 37] by
an affirmative vote.

(5) A local government that complies with [sections 1 through 37] is not subject to any provision of
Title 76, chapters 1, 2, 3, or 8.

20	capacity, or othe	r documented constraints, the local government shall establish the minimum number of	
21	housing units that	at may be rehabilitated, improved, or developed within the jurisdiction over the 20-year planning	
22	period and the ad	ctions the local government may take to remove constraints to the development of those units	
23	over that period.		
24	(4)	Progress toward the construction of the housing units identified as needed to meet projected
