Background Materials and Research

Topic Summary:

In 1978, Congress enacted a National Energy Act, which included PURPA. PURPA, 16 U.S.C. 824a-3, establishes requirements for the purchase and sale of electric power between qualifying small power production facilities (QFs) and electric utilities under the regulation of the PSC.

In 1981, the Montana Legislature enacted QF laws, referred to as "mini-PURPA" and codified in Title 69, chapter 3, part 6. Montana law authorizes QFs to contract for the sale of electricity to regulated public utilities. Federal law requires all state-regulated utilities to purchase QF power offered by qualifying cogeneration and small power production facilities either at a freely negotiated rate or at a rate set by the Montana Public Service Commission (PSC). In Montana, there are close to 40 QFs with the collective capacity to produce on average about 160 megawatts of electricity annually.

Montana's PSC in the last five years issued several orders related to avoided-cost price for QFs. The issue of contract length also has been visited by the PSC on multiple occasions. Several recent decisions also have been challenged in District Court and appealed to Montana's Supreme Court. QF requirements in Montana continue to be controversial.
