Background Materials and Research

Topic Summary: State law requires a Montana resident to register all motor vehicles, trailers, semitrailers, pole trailers, and travel trailers to operate on Montana's public highways. This registration is displayed as a license plate. The Department of Justice's Motor Vehicle Division assess an annual fee for registration, which is collected by county treasurers or authorized agents. The department assesses additional fees for personalized or specialty license plates. Registration is required for:

- Boats, personal watercraft and motorized pontoons¹
- Commercial and heavy vehicles²
- Light vehicles (12-month, 24-month, or permanent)³
- Motor homes⁴
- Motorcycles and quarcycles⁵
- Snowmobiles⁶
- Trailers and travel trailers⁷

Most of the fees go into the state's general fund. However, in recent sessions these registration fees have been identified as funding sources for specific programs, such as state parks maintenance, off-highway vehicle trails, snowmobile trails, boating facilities, veterans' services, and search and rescue
