

EXEMPT GROUND WATER WELLS

LEGISLATOR NOTICE

Background Materials and Research

Topic Summary: State law requires a water rights permit for all new beneficial uses of water, except for **appropriations** from a well or developed spring:

- for a local governmental fire agency to be used only for emergency fire protection, emergency fire training, and emergency fire-related operations, including storage;
- of 350 gallons a minute or less for nonconsumptive geothermal heating or cooling exchange applications; or
- of 35 gallons a minute or less and not more than 10 acre-feet a year.

These exempt appropriations must be outside a designated controlled ground water area or a stream depletion zone. A combined appropriation of two or more wells or developed springs from a same source may not exceed a volume of 10 acre-feet a year.
