# **WATER COURT**

### Background Materials and Research

**Topic Summary**: The 1979 Legislature created the Montana Water Court to conduct the litigation phase of water right adjudication. The Legislature had previously created the process of water right adjudication in 1973 to determine the quantity and priority date of all existing water rights in a hydrologic basin. Prior to this legislation, a person held a water right through a district court decree or by simply putting water to use. The 1973 legislation, known as the Water Use Act, required water users to file a water right claim with the state by 1982 (with exceptions).

The Department of Natural Resources and Conservation examines each claimed water right and forwards this information to the Water Court. The court then subjects each right to public notice and subsequently holds hearings on any objections to a water right. For example, a neighbor may assert that a water right claimant claims too much water, an incorrect diversion point, or wrong diversion date. After a hearings process and a settlement or court ruling, the court issues decrees for each of the state's 85 hydrologic basins. District courts use these decrees when enforcing water right priorities during times of water shortage.

The Water Court is comprised of a chief water judge, an associate water judge, and various water masters. After adjudication, state law envisions a much-smaller role for the court, including aiding district courts in a water distribution controversy and reviewing appeals of DNRC decisions on water right permit and change applications (until 2025).
