

# WINE LAWS

## LEGISLATOR NOTICE

## Background Materials and Research

**Topic Summary:** Montana's alcoholic beverage code (Title 16) provides a definition of wine, table wine, and sacramental wine. The definitions vary mainly in the amount of alcohol by volume. Wine can have up to 24% of alcohol by volume, but the main subset of wine--table wine--contains not more than 16% alcohol by volume. In Montana the definition of "table wine" also includes "cider," which is separately defined under "hard cider" as "an alcoholic beverage that is made from the alcoholic fermentation of the juices of apples or pears and that contains not less than 0.5% of alcohol by volume and not more than 6.9% of alcohol by volume... ." Wine laws relate to:

- Wine Retail Sales.
  - For off-premises consumption: Sales may be from a winery, an agency liquor store, a grocery, a pharmacy, a stand-alone wine shop, or from sales in the original packaging from a bar with an all-beverage license or an on-premises licensee (bar or restaurant) with a beer license and wine amendment.
  - For on-premise consumption. On-premises sales can be at a winery or at a restaurant or a bar.
- Licensing. Excluding county beer licenses with wine amendments, other on-premises licenses are limited by population quotas. The beer (with wine amendment) licenses have had a quota since 1975. The restaurant beer and wine license, created in 1997, requires a certain amount of food inventory.
  - An on-premises license includes an all-beverage license, a beer license with a wine amendment, a restaurant beer and wine license, also known as a cabaret license, and various specialty licenses.
  - An off-premises license requires sales in the original packaging. (See above under off-premises sales.)
  - Special permits, instead of licenses, allow certain tax-exempt organizations, including Montana postsecondary schools, to serve beer and table wine at events on a limited basis. Special permits also cover seasonal sporting events under certain conditions and on-premises sales at veterans' posts or fraternal lodges that do not have a license.
  - A catering endorsement allows a licensee with either an all-beverage license, a beer license (with or without a wine amendment), or a restaurant beer and wine license to cater and sell beer or wine at special events held

at locations not otherwise licensed for the sale of beer or wine. For a restaurant beer and wine license with a catering endorsement, food costs must equal 65% of total gross catering revenue. Catered wine or beer must be consumed on the premises where the event is held.

- **Manufacturing.** An annual winery license is in addition to permits required by federal law. A U.S. Supreme Court decision found that out-of-state wineries could not be treated differently than in-state wineries. This affected distribution laws then in effect. See below for those changes. Statutes on licensing wineries show a 1987 start.
- **Distribution.** A licensed and bonded winery may distribute directly to retailers. Wineries (no matter where located) with a direct shipment endorsement may ship table wine (not more than 16% alcohol by volume) directly to an individual who is at least 21 years of age. [SB 127](#) in 2007 was enacted in part to address a U.S. Supreme Court decision, *Granholm v. Heald*, 544 U.S. 460 (2005), that held laws in New York and Michigan as unconstitutional because they allowed in-state, not out-of-state, wineries to ship wine directly to consumers. A licensed table wine distributor may distribute directly to retailers. The state's liquor warehouse may distribute wine with more than 16% alcohol by volume to agency liquor stores.

In 2019 there was a bill that addressed taxation of wine and cider, which passed, and bills seeking changes for special events and for restaurant beer and wine licenses, which did not pass. Prior sessions saw bills related to sales of fortified wine and sacramental wine. One bill would have allowed off-premises beer and wine licensees to sell fortified wine instead of just table wine, which is the current limitation. Sacramental wine has a markup of 20%. In contrast, fortified wine with more than 16% but not more than 24% alcohol by volume has a markup of 51%. (See 16-1-404, MCA.)
