Background Materials and Research

Topic Summary: Solitary confinement is a term to describe a practice of housing jail or prison inmates in an isolated setting with restrictions on out-of-cell time, often with additional restrictions on contact with other inmates and visitors and reduced privileges. Solitary confinement is not often used by prison or jail administrators, who use a variety of other terms, including locked housing, restricted or restrictive housing, administrative segregation, segregated housing, special management, or separated housing. But whatever the term used, the basic practices that define restricted housing are similar: inmates are removed from the general population and are confined in a single or double-bunked cell for the majority of the hours in a day with restricted movements, activities, and contact with other individuals.
