

## SCHOOL FACILITY FUNDING

### Background Materials and Research

#### Topic Summary:

School facilities, and in particular mechanisms for state support for school facilities, have received a lot of legislative attention in the past decade or so, and especially following the 2015-2016 School Funding Interim Commission. That commission surveyed education stakeholders around the state for areas of concern related to school funding; school facilities was one of the four top priorities that the commission investigated over the interim, eventually recommending four bills to the 2017 Legislature.

State support for school facilities was an area of concern identified by the court in the *Columbia Falls v. State* decision of 2004 that found the state funding formula to be constitutionally inadequate. A number of changes were made to the formula following that decision. Additionally, the state spent about \$2.5 million to conduct a facilities condition inventory that was completed in 2008 and distributed about \$50 million total in fiscal years 2007 and 2008 for weatherization, deferred maintenance, and capital investment. State support for school facilities has decreased significantly since that time.

For the 2019 biennium, the two programs for state support—debt service assistance and major maintenance aid—were not funded due to state budget cuts. Debt service assistance provides state support to low property wealth districts in paying off bonds for new construction or major renovation of school buildings. Major maintenance aid was created in 2017, replacing the Quality School Facility Grant Program. It supplements local effort through a new limited permissive levy within the school district building reserve fund for major maintenance. Both programs received funding in both the 2021 and 2023 bienniums, but debt service assistance is still only partially funded.

In both 2019 and 2021 sessions, lead remediation for school water systems has received legislative attention and the major maintenance aid program has been revised in several ways.
