# EMERGENCY MEDICAL SERVICES

### Background Materials and Research

#### **Topic Summary:**

Emergency medical services (EMS) are a crucial service for the citizens of Montana, and most are provided through fire districts, municipal fire departments, medical centers, military affairs, or a combination. Ultimately, emergency medical services are under the authority of county governance, and counties are responsible for securing funding and services. <u>Title 7, chapter</u> <u>33, MCA</u> contains statutes related to rural fire districts, fire service areas, and municipal fire departments, all of which have an obligation and authority to secure emergency medical services for their respective areas.

The Department of Military Affairs may provide other emergency services during declarations of emergency or disaster, as provided in <u>Title 10, chapter 3, MCA</u>. In addition, the state mandates that every public and private safety agency establish and participate in an emergency telephone system (9-1-1), the creation, operation, and funding of which are detailed in <u>Title 10, chapter 4, MCA</u>.
