CSCT: SCHOOL-BASED MENTAL HEALTH SERVICES

Background Materials and Research

Topic Summary: The Department of Public Health and Human Services created the Comprehensive School and Community Treatment (CSCT) program in 2005. The program is not established in statute. Instead, DPHHS created the program through administrative rules, under its broad statutory authority to administer the state Medicaid program and to provide services to children. The program allows schools to offer mental health treatment in the school setting to children who, in most instances, have a diagnosis of Serious Emotional Disturbance (SED). Schools may offer the services themselves or contract with a licensed mental health center for the services. Schools also must provide the required matching funds to draw federal Medicaid dollars. Until recently, schools been using in-kind contributions as the match.

The Centers for Medicaid and Medicare Services notified DPHHS in 2016 that the in-kind contributions did not meet federal standards for matching funds. DPHHS negotiated continuance of the in-kind contributions until 2020 and used general fund dollars as the match after that. The 2021 Legislature passed a bill requiring the Office of Public Instruction to facilitate school district reimbursement for the CSCT program and to collaborate with DPHHS to develop the funding method. The state now requires school districts to provide a cash match up front to obtain federal Medicaid funding for the services.
