SUICIDE PREVENTION

Background Materials and Research

Topic Summary: For all age groups, Montana has been in the top five in the nation for suicide rates for the past 30 years. The high rate of suicide has prompted a variety of legislation and other action at the state level. As long ago as 2007, the Legislature took steps to address concerns over the suicide rate when it created – in law – the position of suicide prevention officer and required the Department of Public Health and Human Services (DPHHS) to develop a plan every 2 years to reduce the number of suicides in Montana. Subsequent action has ranged from establishing a temporary Montana Suicide Mortality Review Team to funding prevention efforts and monitoring, during the interim, suicide prevention activities and best practices.
