Background Materials and Research

Topic Summary: An off-highway vehicle is defined in Montana law, [section 23-2-801](#), as a self-propelled vehicle used for recreation or cross-country travel on public lands, trails, easements, lakes, rivers, or streams. Montana Legislation in the last 10 years has focused on further defining the definition of off-highway vehicles as well as the requirements and permits for those vehicles.

Legislative Services Division Materials: As stated in the MCA, "off-highway vehicle" means a self-propelled vehicle used for recreation or cross-country travel on public lands, trails, easements, lakes, rivers, or streams. The term includes but is not limited to motorcycles, quadricycles, dune buggies, amphibious vehicles, air cushion vehicles, and any other means of land transportation deriving motive power from any source other than muscle or wind. The definition does not include vehicles designed primarily for travel on, over, or in the water or snowmobiles.
