Notes:

- 1. The FAA has not identified if WYS will qualify for \$150k or \$1M in Primary Entitlements in 2022 as a result of reduced emplanements in 2020 due to COVID. Reflecting \$1M as BIL funding reflected at higher airport classification amount.
- 2. Enplanements above FAA threshold in 2021 to justify \$1M in Primary Entitlement funding.
- 3. Consider borrowing Primary Entitlements and BIL from other airports to payback in future. Could potentially borrow all three years of Primary Entitlements and BIL funds in 2022.
- 4. The full extent of FAA ineligible items is not known to provide an overall Sponsor responsibility figure at this time.
- 5. \$5 Billion in additional terminal funding through the BIL but specifics and WYS eligibility not yet known.
- 6. MMI proposed schedule is phasing the bid awards through FY22 in order to align the project more closely with the anticipated receipt of federal funding and the subsequest request for additional state spending authority through A&E
- 7. water/sewer/new access road/existing access road rehab, parking lots, apron expansion could be delayed until the 2023 construction season pending funding

Transfer CARES O&M authority from MDT to A&E for AIP match. Some O&M authority will remain at MDT for potential equipment purchases & WY spend. We could use all CARES O&M authority on the terminal providing another \$1 million of available funding

Proprietary authority will be used for matching the entitlement/discretionary FAA funding.
