Subject: Taxability of Coronavirus Relief Fund Grants in Montana

This memorandum provides estimates of the percentage of Coronavirus Relief Funds that are likely to be taxable in Montana. The Department of Commerce has a publicly available list of all the awarded grants as of December 28, 2020 with a total awarded amount of \$738,102,222. I aggregated these individual grants by the grant program and determined which of the grant programs were likely to be taxable based on the description and intended recipients. Of the 21,588 grants awarded, 17,675 of them are assumed to be taxable. The total grant amount of the taxable grants is \$362,476,065, or about 49 percent of the total amount of grants awarded. The following two tables show the number and amount of grants aggregated by grant program for the grant programs that are assumed to be taxable in the first table and not taxable in the second table.
