Restraint of trade concerns and unfair trade practices

- 06:27:58 Ken Provencher, CEO and President of Pacific Source, based in Springfield, Ore., said Pacific is also involved in Medicare Advantage as well as insurance for the non-Medicare market. He talked about the Affordable Health Care Act if the U.S. Supreme Court doesn't rule it illegal and said there are four factors that will help determine what Pacific will do with future policies:

 - the elections in November,
 - the time frame for changes in the law, and
 - the state's budget.

When he first came to Montana he applied for a license to practice in January and received his license in March. Now, he said, it takes months for the application process to go through the Board of Medical Examiners.
- 07:15:21 Dr. Paul Cook, president of the Rocky Mountain Health Network in Billings, said he teaches medicine to interns. He gave an example of the process he has gone through to apply to practice medicine in Montana.
- 07:24:23 Sheila Wirt, medical staff coordinator with Northern Montana Hospital in Havre, gave an overview of her duties and how Northern processes applications when filling medical positions. Ms. Wirt proposed that the licensing process be expedited

Presumptive Illness for Firefighters

00:10:27 Joe Sands, Firefighters Local 521, Billings, talked about presumptive illness for firefighters, such as cardiovascular disease, and commented on a study done in 2010-2011 by the Labor-Management Advisory Council. He referred to a handout showing the health risks that firefighters are exposed to. [Exhibit 2 & Exhibit 3](#) He talked about the various forms of cancer that firefighters are subjected to from chemicals. He said the federal government passed a bill called the Responder Act, which will cover certain presumptive illnesses for responders to the World Trade Center on Sept. 11, 2001. [Exhibit 4](#) Mr. Sands asked that the committee sponsor HB505 as it was amended in the 2011 Legislature. [Exhibit 5](#) He also distributed testimony given on behalf of HB 505. [Exhibit 6](#)

00:20:37 Doug Neil, Montana State Fireman's Association, reiterated comments by Mr. Sands. He urged the committee to carry HB 505, and introduce it in the upcoming Legislature.

00:25:56 Ann Komac, claims manager for the Montana Municipal Interlocal Authority (MMIA), Helena, said the MMIA administers a "risk retention pool" for cities and towns in Montana, providing property, liability, workers' compensation, and employee benefits for local government employees, including firefighters. She discussed her concerns with presumptive illnesses and recommended that the committee leave well enough alone. She stated that firefighters have a right to file a claim as long as they have proof of work-related injury.

00:30:08 Harold Blattie, Executive Director of the Montana Association of Counties (MACo), said that other states do have presumptive illness provisions. He discussed HB 505 from the 2011 Legislative session and said "that coverage [of certain illnesses] is not precluded, it's just the burden of proof." [A presumptive illness provision would require a lesser burden of proof for the firefighter.]
