COMMITTEE ACTION

- The Environmental Quality Council (EQC) approved the minutes from July 9-10, 2014, as amended.
- The EQC voted 16-0 to approve the SJ 4 study report and LC MHC1 as a committee bill.
- The EQC voted 16-0 to approve the formation of a joint subcommittee between the EQC and the Energy and Telecommunications Interim Committees (ETIC) on the Environmental Protection Agency (EPA) rule on the Clean Power Plan.

- The EQC voted 16-0 to approve initial drafting of legislation proposed by the Department of Natural Resources and Conservation (DNRC).

- The EQC voted 11-5 to approve initial drafting of legislation 1-6, proposed by the Department of Fish, Wildlife, and Parks (FWP).

- 00:01:31 Sen. Brenden asked if the EQC members have had all of their questions answered by staff and the state agencies. He asked if there were any corrections or additions to the minutes.

- 00:02:17 Hope Stockwell, research analyst, LSD, said at time stamp 07:35:17 the amount should be \$191,000.
- 00:03:19 **Motion/Vote:** Sen. Keane moved to accept the July 9-10, 2014 EQC minutes as amended. The motion carried unanimously by voice vote.

PETROLEUM TANK RELEASE PROGRAM/FUND COORDINATION UPDATE

- 00:05:26 Tom Livers, deputy director, DEQ, said one of the items in the audit done by the EPA on the solvency of the Petroleum Tank Release Cleanup Fund was to do more formal strategic planning. He said the DEQ is looking at how it does business and how to do it as efficiently and effectively as it can.
- 00:08:40 Terry Wadsworth, executive director, Petroleum Tank Release Compensation Board (PTRCB), DEQ, gave an update on the Petroleum Tank Release Cleanup Fund and discussed the three priorities of the strategic plan.
- 00:13:01 Mike Trombetta, chief, Hazardous Waste Cleanup Bureau, DEQ, discussed risk and how the agency uses risk in cleaning up sites and said one of the tools used is petroleum mixing zones. He also discussed how the DEQ and the PTRCB are working together as part of the strategic plan. He provided a copy of the snapshot that the EPA requested in its Tier II fund solvency report, [Exhibit 1](#).

- 00:25:12 Sen. Keane asked if part of the strategic plan is to do more cleanups and less monitoring. Mr. Wadsworth said it is.
- 00:26:10 Sen. Keane asked if there needs to be legislation in order to tie the closing of sites to petroleum mixing zones. Mr. Trombetta said the tools are already in place to do that.
- 00:27:36 Sen. Keane said the legislators who are on the EQC during the next interim need to focus on cleaning up sites and making sure sites are being closed.
- 00:28:07 Rep. Lieser asked if a MEPA analysis is required. Mr. Trombetta said MEPA is a consideration in all of the decisions the department makes and it meets all the functional requirements of MEPA.
- 00:29:17 Mr. Morris commented that Sen. Keane's bill, (HB 613, 2011), to close 90 sites a year set a definite goal for closing sites and pushing things forward. He asked if a large and costly release happens in the future if there is enough capacity in the fund to clean it up, and if not, what would happen. Mr. Wadsworth said if there is a catastrophic release that took a million dollars out of the fund a large portion of the PTRCB revenue would be pushed toward that site and other sites would not be funded.

SAGE GROUSE MANAGEMENT PLAN UPDATE

- 00:32:32 Tim Baker, natural resource policy advisor, Governor's Office, gave an update on the Greater Sage-grouse management plan and discussed the executive order issued by the governor to keep the management of the Greater Sage-grouse in the hands of the state, Exhibit 2.
- 00:46:19 Jeff Hagener, director, FWP, said the department is working with the Governor's Office to implement the plan. He said the Fish and Wildlife Commission approved cutting back on the sage grouse hunting season and closed hunting in the eastern part of the state. He said FWP is also working in coordination with the ten other states that will be affected if the Greater Sage-grouse is listed as an endangered species.

01:05:08 Sen. Ripley asked about the total cost of the executive order. Mr. Baker said there are two pieces to the executive order, staffing, and the Habitat Conservation Fund for voluntary incentives on private land. He said staffing will cost approximately \$600,000 per fiscal year and said the fund will cost several million dollars.

01:06:40 Sen. Ripley said the EQC will need more details in order to approve funding for the executive order. Mr. Baker said the governor plans on going to the legislature and seeking funding approval through the budget process.

01:08:06 Sen. Ripley said when more details about funding are available it can be looked at before the legislative session. Mr. Baker said they can go through the funding process together and engage the help of the legislature.

01:08:56 Sen. Fielder asked if he anticipates lawsuits despite efforts to keep the sage grouse from being listed. Mr. Baker said there will probably be litigation, but it will be better if there is a plan in place.

01:10:59 Sen. Fielder asked why it is importance to keep management of the species in state hands rather than the federal government. Mr. Baker said it is better and more powerful to give local stakeholders the opportunity to determine how the sage grouse is managed.

01:13:07 Rep. McChesney said the Greater Sage-Grouse Habitat Conservation Advisory Council made sure that the plan would meet any litigation that might be brought forth. He also said because of the way the Endangered Species Act is written the U.S. Fish and Wildlife Service (USFWS) has to look at the entire habitat range which involves 11 western states. He said state management is important because Montana can develop a plan to address issues that are unique to the state.

DEVOLUTION OF CANADA LANDS TO NW TERRITORIES

03:22:35 Sen. Brenden gave an introduction and provided background information on the devolution of Canada lands.

03:25:07 Sen. Brenden asked Martin Goldney, chief negotiator, Government of the Northwest Territories, via phone, if he was the chief negotiator for the government of the Northwest Territories on the devolution of lands and resources. Mr. Goldney said he was.

03:25:34 Sen. Brenden asked how long it took for the negotiations. Mr. Goldney said the most recent round of devolution negotiations started in 2002 and concluded in 2012.

03:26:06 Sen. Brenden asked if the Yukon Territory had gone through devolution by the time the Northwest Territories started. Mr. Goldney said the Yukon Territory was just concluding its negotiations and beginning implementation when the Northwest Territories started negotiations.

03:26:25 Mr. Goldney discussed the devolution of the Northwest Territories, the transfer of province-like authority to its government, and some of the challenges.

03:38:58 Sen. Brenden asked if the Northwest Territories and Canada make joint control decisions. Mr. Goldney said some of the environmental regulations are done jointly, but the bulk of the decisions are territorial government decisions.

03:40:23 Sen. Brenden asked about revenue sharing between the Northwest Territories and Canada and if it is subject to a cap. Mr. Goldney said there is revenue sharing and explained.

03:41:29 Sen. Brenden asked if there are still transfer payments coming in from the federal government of Canada. Mr. Goldney said there are.

03:42:18 Sen. Brenden asked about the agreement with the Canadian government on liabilities before the Northwest Territories assumed control of the land. Mr. Goldney said the general rule is if the liability was created when Canada had control the federal government assumes that liability and continues to be responsible for the cleanup.

03:44:42 Sen. Brenden asked if there are any shared liabilities. Mr. Goldney said there are and gave some examples.

03:46:19 Sen. Brenden asked if First Nations people get 25% of the resource revenue. Mr. Goldney said they do receive 25% of the resource revenue that the government of the Northwest Territories shares with the federal government.

03:47:46 Sen. Keane asked if the Northwest Territories are responsible for complying with all environmental regulations of Canada and the Northwest Territories in permitting new projects. Mr. Goldney said yes.

03:49:01 Sen. Keane asked about funding for new jobs that were transferred to the Northwest Territories. Mr. Goldney said as part of devolution negotiations an additional amount of money was negotiated to pay for employees and for the operations required as land managers.

03:50:51 Sen. Keane asked if protection of the land in the Northwest Territories has increased. Mr. Goldney said yes.

03:51:42 Sen. Hamlett asked if Canada always retains a percentage of the mineral royalties. Mr. Goldney said it does as long as the Northwest Territories are still receiving transfer payments from the Canadian government.

03:52:29 Sen. Hamlett asked if most of the mineral rights are owned by the federal government. Mr. Goldney said they are.

03:53:59 Sen. Hamlett asked if the Indian Reserves in Canada own the mineral rights. Mr. Goldney said they do not.

03:55:57 Mr. Aspenlieder asked if resource production on the transferred land covers the cost of management of the land. Mr. Goldney said it does and that there are two sources of money.

06:40:45 Mr. Kolman explained that the agencies the EQC has oversight over will be presenting their proposals for legislation in order to seek approval to have their ideas pre-drafted into bills. He said if the EQC approves the proposals, it will allow the bills to be introduced at the beginning of the legislative session.

Department of Natural Resources and Conservation

06:44:07 John Tubbs, director, DNRC, discussed the proposed legislation from the DNRC, [Exhibit 17](#).

Committee questions and discussion

- 06:59:45 Sen. Brenden asked how the proposed legislation revising assessments on owners of classified forest land will affect logging companies and if the DNRC has estimated the amount of money that will be generated. Bob Harrington, administrator, Forestry Division, DNRC, explained how the companies will be affected. He said Ms. Altemus will explain the fiscal note during public comment.
- 07:01:18 Sen. Brenden asked about the fiscal note for the proposal to extend and modify the water adjudication account. Mr. Tubbs said if it is done as a one-time transfer to the adjudication account it will be around \$14 million to bring it to termination. He said if it is done as a base budget adjustment it will be about \$2.5-3 million for the biennium.
- 07:02:01 Sen. Brenden asked if under legislation for the cabin and home site sales, DNRC is going to incorporate having the lessee pay for the appraisal rather than the state. Mr. Tubbs said the current draft includes a voluntary provision to amend the statute so if a lessee wants to speed up their process they can choose to pay for those costs.
- 07:03:15 Sen. Brenden asked if the proposed legislation involving trespass uses of school trust land precludes public camping. Mr. Tubbs said it does not. Shawn Thomas, administrator, Trust Land Management Division, DNRC, explained the legislation.
- 07:05:51 Sen. Keane asked about proposed legislation under the conservation and resource development division for conservation districts. Mr. Tubbs said the legislation cleans up procurement statutes.
- 07:06:39 Sen. Keane asked if it includes prevailing wage. Mr. Tubbs said under Montana law DNRC will comply with prevailing wages, but he did not think it was a specific provision of the bill.

- 07:06:57 Sen. Keane asked for clarification regarding water adjudication fees paid by some individuals, but not others, and asked for clarification regarding the fiscal note for water adjudication. Mr. Tubbs said exercising the fee only lasted one legislative session. He said the \$14 million is a one-time revenue transfer method of funding the proposal and the \$2.5-3 million is what would be needed to appropriate as a base fund adjustment to the court and to the DNRC to fund the FTE's in the current operation.
- 07:09:53 Sen. Keane asked if employees have already been transferred from the DNRC to the water court. Mr. Tubbs said they have been and they will continue to do so as their work gets done.
- 07:10:51 Sen. Keane asked if they are moving from water adjudication to funding the water court to get the process done. Mr. Tubbs said water adjudication is a two part process by both the DNRC and the water court. He said the DNRC is responsible for examination and the water court has the responsibility for the actual adjudication and decrees.
