IMPORTANT NOTICE:

- * If your taxes are paid by a Lending Agency, PLEASE FORWARD this Notice IMMEDIATELY TO THE LENDER.
- * If you no longer own this property PLEASE FORWARD it to NEW OWNER or RETURN TO TREASURER.
- * Notices ARE NOT MAILED for Second Payment. -->STUB(S) MUST ACCOMPANY PAYMENT.
- * Please enclose self addressed, stamped envelope if paid receipt is requested.

Examine this bill carefully before paying. See that all legal descriptions are correct and that they cover ALL the property on which you intend to pay and no other. The County Treasurer is not responsible for payments made on wrong property and payments so made cannot be refunded.

TO PROTEST YOUR TAX:

1. Pay the current tax in full.
2. Attach a letter stating why you are protesting and the amount you feel is in error.
3. Proceed with legal action within 90 days.

TO APPEAL YOUR VALUATION:

1. You MUST HAVE FILED your appeal prior to the 1st Monday of June in any tax year.
2. You CANNOT appeal your valuation at time of payment.

A DELINQUENT TAX CANNOT BE PROTESTED OR APPEALED.

Taxes on real estate or mobile homes may be paid in two installments, the first installment on or before date due as shown on front and the second installment on or before date due shown. If the first installment is not paid on or before said date, then the amount of this FIRST INSTALLMENT becomes delinquent. If the SECOND INSTALLMENT is not paid on said date, then the amount of the second installment becomes delinquent. When either installment becomes delinquent, a penalty of 2 percent is immediately added thereto, together with interest at the rate of 5/6 of 1 percent per month until paid. Payment of delinquent taxes must be applied to the taxes that have been delinquent the longest.

The TAXPAYER is responsible for ensuring that a timely postmark is obtained for payments remitted by mail.

If you are low income, elderly, a veteran, or had a large increase in your property taxes due to re-appraisal, you may qualify for tax assistance. Contact the DOR at (406) 932-5149 for more information.

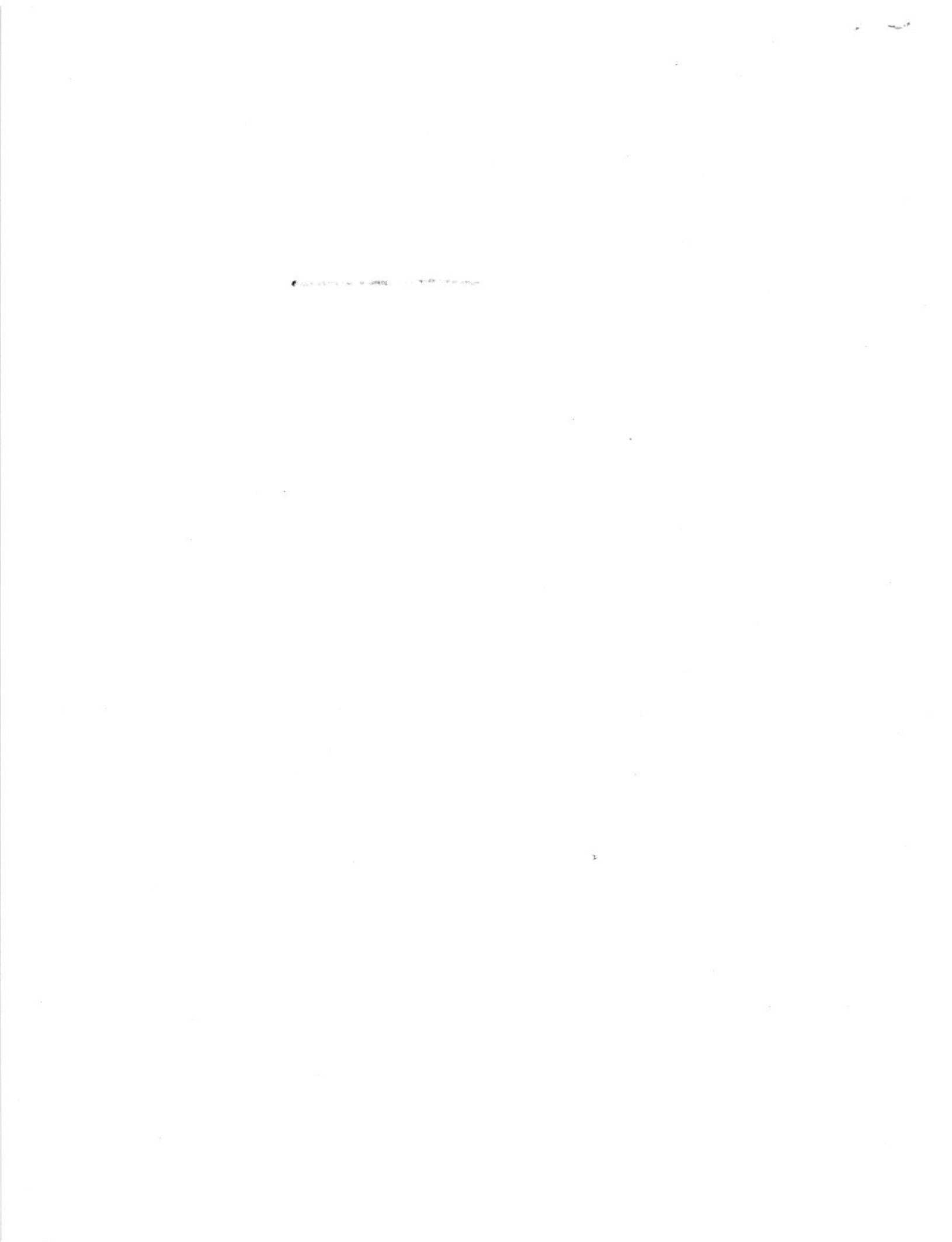
