

SB 423: Montana Marijuana Act
Registry Statistics
as of Nov. 30, 2015

Statistics maintained by the Department of Public Health and Human Services (DPHHS) provide the following information about individuals registered as of Nov. 30, 2015, to cultivate, manufacture, or possess marijuana for use for a debilitating medical condition as allowed under Senate Bill 423. A comparison with previous months shows changes that have occurred since SB 423 went into effect.
