What is the total current budget for Montana's Government What amount of the total budget is attributable to each of the three branches of Montana's Government?

The following table lists FY 2016 and FY 2017 budgeted funding for each branch of government from all sources, including federal special funds, state special funds, and proprietary funds. The table does not include funds for the Montana University System.

The table includes potential HB 2 trigger language that is authorized, but has not been established in SABHRS as of 11/30/2015. Other bills and HB2 language including potential triggers are included in the biennium column. For the Legislative Branch, this column includes HB1, which funds the operation of the Legislature.
