## PASSAGES PRERELEASE

Passages is a community corrections facility located in Billings that provides supervision and services to adult female offenders. Passages is operated by Alternatives, Inc., and it includes a prerelease facility, as well as an assessment, sanctions, and revocations unit and an inpatient alcohol and drug treatment unit. The prerelease unit has 76 beds, while the assessment, sanctions, and revocations unit and the inpatient treatment unit both have 50 beds.

The LJIC will be touring the prerelease facility. The Department of Corrections contracts with Passages for several services, including the prerelease beds. Passages also houses federal offenders.

Passages completed its most recent Prison Rape Elimination Act (PREA) audit in November 2016. The facility met or exceeded all of the 41 applicable standards, although 5 of those standards required corrective action before compliance was achieved.
