# YELLOWSTONE COUNTY DETENTION CENTER

The Yellowstone County Detention Center is an adult detention facility operated by the county. It houses adults who have been charged with criminal offenses or are being held post-sentencing until they can be transferred to a prison or other corrections facility. The county has gradually expanded the detention center's capacity over the years and is in the final stages of constructing a 148-bed women's unit.

Counties may establish detention centers (more commonly known as "jails") and are required by Montana law to provide individuals held in the detention center with "necessary food, clothing, and bedding." The county also has the "duty of building, operating, inspecting, and repairing the detention center and must take all necessary precautions against escape, sickness, or infection." In addition, detention centers must comply with state and local fire codes as well as sanitation, safety, and health codes.
