NOTICE DESCRIPTION: (e.g. proposal notice/adoption notice): Notice of Proposed Repeal

SUMMARY OF RULE(S): The Department of Administration ("Department") proposes to repeal three rules relating to definitions concerning the statewide emergency telephone system, participation requirements for public and private safety agencies in 9-1-1 jurisdictions, and distribution requirements for the wireless enhanced 9-1-1 account.

The affected rules implemented or were authorized by statutes that were repealed on July 1, 2018. Chapter 367, L. 2017, revised and updated the 9-1-1 laws and funding mechanisms, and the Department notes that it "has completed distribution of funds under the program eliminated by [Ch. 367, L. 2017] and has begun distribution under the new statutes and rules that resulted from the legislation. Therefore the rules being repealed are no longer necessary."

NOTES: No hearing is contemplated. The public comment period ends on November 16, 2018.
