COMMITTEE ACTIONS

The Committee met by conference call to hear a presentation and take public comment, as required by law, on the waiver application the Department of Public Health and Human Services must submit to the federal government to continue Medicaid expansion in accordance with House Bill 658 (2019). That bill imposes community engagement requirements for certain expansion enrollees and also calls for gradually increasing premiums from 2% to 4% of an enrollee's income, depending on the number of years the person remains in the expansion program.

The Committee also reviewed and adopted a revised interim work plan, after deciding to decrease the number of hours spent on a study of the child protective services system in order to reserve 5 hours of committee time to hear about any health and human services issues that may emerge during the interim.
