COMMITTEE ACTIONS

During a two-day meeting in Billings, the Committee heard presentations and visited sites related to three of its studies. Study activities included:

- presentations and a demonstration related to a perinatal behavioral health initiative funded by the Montana Healthcare Foundation and the Department of Public Health and Human Services to screen pregnant women for substance use and mental health disorders and connect them with appropriate treatments;
- a panel discussion of issues affecting nursing homes and assisted living facilities, as well as tours of two facilities; and
- information from parties who represent children, parents, and DPHHS in abuse and neglect cases, district judges who hear the cases, and DPHHS caseworkers who investigate abuse and neglect reports and work with families whose children have been removed from the home.

The committee also visited Passages community corrections facility and spoke with women offenders whose children are in foster care; toured psychiatric facilities at the Billings Clinic; and visited the Billings Community Crisis Center.

The committee also received several DPHHS reports that are required by law, heard an agency update from DPHHS Director Sheila Hogan, and received a summary of public comment related to proposed administrative rules revising public health standards for schools. Members asked to review the final version of the rules before DPHHS adopts the rules and also asked that an agency representative speak about the public health reasons behind the proposed rules when the committee meets in January.
