- an in-depth presentation on how the Department of Public Health and Human Services:
 - assesses whether a child is in imminent or impending risk of harm and should be removed from a home;
 - develops treatment plans and establishes conditions that must be met for the child to return home; and
 - monitors whether parents are meeting the conditions for return.
 - the impact that the increase in child protective services cases in recent years has had on the court system and steps that courts are taking to speed up and improve the handling of the cases;
 - an overview of three Medicaid-funded home and community-based services programs for the elderly and people with physical disabilities; and
 - a recap of the testimony by proponents and opponents to Senate Bill 202 in 2019. That bill, which failed, would have adopted the 2017 uniform guardianship law that was developed by a national commission.

The committee also received several DPHHS reports that are required by law and heard an agency update from DPHHS Director Sheila Hogan.
