<p><b>LL Liquor: before the 9th Circuit Court of Appeals.</b> The question relates to damages owed to LL Liquor for a court-determined Montana breach of contract. The Department argument is that under state law the State owes no damages for a period of two years from the judgment ordering damages. LL Liquor argues that the State owes interest of 10% per year. The District Court ruled that the State owes LL Liquor 1.79% interest on the \$5,000,000 judgment amount pursuant to 26 U.S.C. 1961.</p>
