Section 1. State funding to eliminate reduced-price co-payments for school 12 lunch and breakfast -- legislative intent -- rulemaking. (1) The legislature intends to strengthen the 13 opportunity of each child to develop the child's full educational potential in accordance with the goal of the 14 people articulated in Article X, section 1(1) of the Montana constitution and recognizes that: 15 (a) adequate and proper nutrition is a foundational requirement for learning; and 16 (b) requiring families that are eligible for reduced-price school meals under the federal school breakfast 17 program and national school lunch program to contribute to the cost of meals creates a barrier for participation 18 and a burden for school administrators for accounting and collection. 19 (2) From money appropriated for this purpose, the superintendent of public instruction, shall administer 20 a program to distribute replacement funds to school districts electing to eliminate required reduced-price co-21 payments from reduced-price eligible pupils for school lunch and breakfast under a federal program. The 22 superintendent shall adopt rules necessary to administer the program. 23 (3) If appropriated funds are insufficient for the program, the superintendent of public instruction: 24 (a) may accept donations from private or out-of-state public sources to support the program; and 25 (b) shall request additional funding sufficient to support the program in the subsequent biennium.

(4) For the purposes of this section, the following definitions apply:

(a) "Reduced-price copayment" means the amount a reduced-price eligible pupil is charged for

NEW SECTION. Section 2. Appropriation. (1) There is appropriated \$600,000 from the state general fund to the office of public instruction for each of fiscal years 2022 and 2023 for the purposes described in [section 1].
