### **Committee Business Summary**

- Authorized the OPI to proceed in drafting legislation to recommend to the 2021 Legislature regarding adjustments to the transformational learning program enacted in HB 351 (2019).
- Decided to hold a short remote meeting in mid-August focusing on continuing its work on pre-kindergarten and HJ 56, the study of bullying that the committee expanded to student well-being generally.
- Provided direction to staff on various topics including direction to prepare bill drafts for eliminating reduced price co-pays for school breakfast and lunch and for explicitly authorizing in statute "Handle with Care" programs in which law enforcement and first responders communicate to schools that a child may have experienced a traumatic experience outside of school.
- Approved nine bill drafts related to school funding as committee bills to recommend to the 2021 Legislature and an additional bill draft revising EDIC's duties related to the Montana University System.
- Voiced support for the proposal to include funding for paying all or a portion of the state's dues as a member of the Compact for Education and the Education Commission of the States in the Legislative Services Division budget.
