16	(e)(3) board of regents of higher education; and	
17	(d)(4) office of public instruction.	
18	(2) The committee shall:	
19	(a) provide information to the board of regents in the following areas:	
20	(i) annual budget allocations;	
21	(ii) annual goal statement development;	
22	(iii) long-range planning;	
23	(iv) outcome assessment programs; and	
24	(v)—any other area that the committee considers to have significant educational or fiscal policy impact;	
25	(b) periodically review the success or failure of the university system in meeting its annual goals and

Commented [MP1]: As discussed previously, the entirety of subsection (2) was added from the former statutes establishing the Postsecondary Education Policy and Budget (PEPB) committee which was staffed by LFD and included members of the Board of Regents and a representative from the GOV's office. Removing these duties does not diminish EDIC's responsibility or authority in monitoring the Board of Regents, OCHE, or the MUS under subsection (1).
