<p>HB 387 - Provide advanced opportunity aid</p> <p>% of district's QE payment to Flex Fund</p> <p>≥ 60% must be used to offset student costs of AP tests, WBL experiences, IRC exams, dual credit tuition, etc. Remainder can be spent on CTE</p>	<p>8 districts funded FY 21</p> <p>25 waitlisted for FY 22 (with additional capacity for others)</p> <p>Next window to submit: Dec 2020 to Jan 2021</p>	<p>Funding ramps up over 4 years at which point all districts can be funded</p> <p>No termination date</p> <p>With funding of all districts and no termination, do the problems with HB 387 correct themselves within 4 years?</p> <p>Can be supplemented with additional expenditures from Adult Ed Fund up to 25% of total aid</p>	<p>Who evaluates/selects candidates to be funded?</p> <p>How do you ensure grantees are representative geographically/ population size/etc.?</p>	<p>Should districts be allowed to save funds to make a large purchase in a subsequent year? Or spend all funds in the year received?</p> <p>How to provide assurances for quality, continuity of the program over time? Should later funds be conditioned on success of the program?</p> <p>What does accountability look like for a transformational learning program? Should someone be responsible for monitoring implementation? What is the Legislature's role?</p> <p>Is there a clearer definition of "transformational learning" to focus on innovative incubators, explorers and pioneers? Is that the intent?</p>
