Dear President Sales and Speaker Hertz:

As required by Montana Code Annotated § 3-1-1126, the Montana Judicial Standards Commission (Commission) submits this report to the legislature for the preceding biennium covering calendar years 2017 and 2018.

Article VII, Section 11, of the 1972 Montana Constitution directs the legislature to create a five-member Judicial Standards Commission to accept and consider complaints against Montana judicial officers. The 1973 legislature created the Commission and it is attached to the Montana Supreme Court for administrative purposes. Mont. Code Ann. § 3-1-1101 through – 1126. The work, investigations, and recommendations of the Commission are independent of the Supreme Court. With few exceptions, all papers and proceedings before the Commission are confidential pursuant to Montana Code Annotated § 3-1-1105. Access to Commission records is limited to the Commission and staff.

The Commission's report to the sixty-fifth legislature (2017 session) showed that 2 complaints were still pending at the close of 2016. Of those pending complaints, one resulted in a Private Reprimand, and the other complaint was dismissed.

As shown in the attached spreadsheet, 46 complaints were filed against judicial officers in calendar year 2017. After consideration and investigation, 44 of those complaints were dismissed, and 2 resulted in a letter of admonition to the judge. There were 2 complaints pending as of December 31, 2017. Of those 2 pending complaints, 2 were dismissed.

For calendar year 2018, 60 complaints were filed against judicial officers. After consideration and investigation, 54 complaints were dismissed and 2

complaints were dismissed with a letter of caution. There were 4 complaints pending as of December 31, 2018.
