# Montana Census 2020 Work Plan – April 2019

## Montana State Complete Count Committee

#### What is the function of the Montana 2020 Census State Complete Count Committee (MT 2020 CCC)?

- The MT 2020 CCC is a volunteer committee established by tribal, state, and local governments and/or community leaders to increase awareness about the census and motivate residents in the community to respond. The CCC is charged with developing and implementing a 2020 Census outreach, promotion, recruitment and enumeration assistance plan of action designed to target and address the needs of their communities.
- The US Census Bureau has structured outreach through the formation of local Complete Count Committees. The State CCC will help to encourage formation of local CCCs, educate the CCCs on best practices and general information, as well as provide necessary resources to form the local CCC, to educate about the importance of the Census and motivate every person to be counted once, only once and in the right place. The State CCC will also aid in the recruitment of Census workers to encourage that trusted voices within the communities are hired to help encourage participation.

#### What is the subcommittee structure of the Complete Count Committee?

- The chairperson(s) lead the overall efforts of the Complete Count Committee in coordination with the Montana Census Bureau (CEIC) and the U.S. Census Bureau Partnership staff within the state.
- For the 2020 Census, the confirmed co-chairs are listed below.
- The chairperson(s) invite and appoint the subcommittee chairs.
- The Complete Count Committee involves most aspects of a local community in the subcommittee structure consisting of the following; Community Services, Economic Development and Business, Government, Library and Education, Tribal.


#### What is the Governor's role and involvement?

- The Governor and the Governor's Liaison is the official contact for the U.S. Census Bureau.
- The Governor can provide the message of the importance of all Montanans to participate
- The Governor can direct agency resources where needed for the successful completion of the census.

#### In 2020 the Lieutenant Governor will perform the following tasks on behalf of the Governor

- Sign letters requesting individuals volunteer to be part of the State Complete Count Committee;
- Select chairmen of various subcommittees with the assistance of the State Complete Count Co-Chairs;
- Issue press release announcing the committee;
- Facilitate the release of the state proclamation about the Census (drafted by CEIC);
- Review regular reports from State Complete Count Committee Chairman on progress and provide feedback;
- Star in promotional spot(s);
- Give a brief presentation at the April 1, 2020 Census Day event.

# **Montana Local Complete Count Committees**

Local Complete Count Committees, comprised of local partners who work with and reach hard-to-count populations, are critical to helping the U.S. Census Bureau reach hard-to-count Californians. Most are led by local governments, such as counties, who work closely with their local committee to ensure outreach efforts are inclusive, effective, and culturally appropriate. Because Local Complete Count Committees know their community best, they are trusted voices and uniquely positioned to ensure that the residents in their communities are counted

Currently twenty-one Local CCCs have formed in Montana with a total of more than 70 planned. The seventy include one in every county, one for each tribe, several for the larger metropolitan areas and several that are topic based that network key state-wide organizations (Seniors, Children, Health Professionals, etc.).

# Local Census Complete Committee (LCCC)Charge

- Set clear, achievable goals and objectives.
- Identify targets (populations or areas) for aggressive outreach through-
- Direct community outreach—touching as many people as possible through swap meets, sports events, festivals, parades, etc.
- Strategic partnerships with counties, schools, state agencies, and community-based organizations.
- Coordinate activities with local CCCs throughout the state.
- Create promotional materials and items for populations or areas identified.
- Create events in key areas where none exist.
- A successful complete count committee involves a number of people, organizations and businesses from every part of the community



#### Introduction

The US Census Bureau will be conducting the 2020 Census and obtaining an accurate count is important in ensuring the Montana receives its fair share of federal funding that is typically apportioned using Census data. The State of Montana will help support the US Census Bureau's Census 2020 counting effort by developing and implementing an outreach and promotional plan. The State's efforts to aid the US Census Bureau will be coordinated by the Montana Department of Commerce; the Census and Economic Information Center within the Research and Information Services Bureau will work with the MDOC's Communications (Comms) Team with assistance from the Department of Labor and Industry (Mary Craigle) to carry out this plan. The State CCC will also coordinate with Census Partnership Specialist, Jeri Bucy, and the other 5 Montana Partnership Specialists to actively encourage and facilitate ideas to aid in the formation and function of local complete count committees across the state.

#### Formation of a Statewide Complete Count Committee (CCC)

- The Statewide CCC was crucial to the 2010 Census effort and will also be in 2020. The proposed 2020 CCC will be much smaller than 2010, anticipated to consist of approximately 15 to 20 members with 3 to 5 members per subcommittee with their primary responsibility to guide Census 2020 outreach efforts and speak to their local groups / constituencies using a standard Power Point presentation developed by CEIC
- The Lt. Governor as the head will give the CCC the authority and visibility needed

#### Outreach

- 1. Develop standard power point presentations that could be customized; target agencies to deliver the power point are as follows: DPHHS, COR, OPI, OCHE, and the Indian Business Expo
- 2. Conduct one-on-one interviews with Reporters / TV / Newspaper /Bloggers that include human or political stories (reapportionment, impact of funding, local census worker hiring)
- 3. Work with OPI and OCHE to distribute an education packet developed by the US Census Bureau to be distributed to every public-school enrollee PK-8 as well as conduct a bookmark contest in schools.
- 4. Enlist CCC members to facilitate engagement in the Census by providing opportunities for education, either themselves or through designated spokespeople, at statewide conferences and events with all categories of audiences.
- 5. Print posters / prepare general displays that show Census funding by county / city and send those across the state to libraries and other places such as the Capitol, SBDC Offices, CRDC offices and other economic development organizations.
- 6. Add information, customized materials to print and links to other's website such as the Legislative Page, Chamber of Commerce, etc.
- 7. Print and provide information to DPHHS, DOR and DLI partners: estimate 5,000 flyers, 500 posters
- 8. Working with the League of Cities and Towns and utility providers (NorthWestern Energy et. al.), write articles to place in the utility bills throughout the state as well as other publications such as the Interim legislative newsletter.
- 9. Develop info to include in Thanksgiving food baskets distributed through Food Share and MCF

Main Components


- Engage and motivate people to self-respond, preferably via the internet
