Assistance for District Court Enforcement of Water Court Decrees

2019 season completed updates and created new projects totaling 63 water distribution areas across the State; of which, 40 are active projects.

Ownership Updates

Department staff validate water right geocodes for property transfers:

- -In 2010, 3,821 ownerships were updated involving 9,460 water rights
- -In 2011, 6,245 ownerships were updated involving 15,765 water rights.
- -In 2012, 8,729 ownerships were updated involving 20,496 water rights.
- -In 2014, 7,618 ownerships were updated involving 18,360 water rights.
- -In 2015, 7,711 ownerships were updated involving 17,483 water rights
- -In 2016, 9,120 ownerships were updated involving 20,358 water rights
- -In 2017, 10,351 ownerships were updated involving 21,797 water rights
- -For 2018, 10,557 ownerships were updated involving 22,293 water rights
- -For 2019, 10,490 ownerships were updated involving 21,217 water rights
- -For 2020, 3,751 ownerships were updated involving 7,480 water rights

Exempt Claim Fillings SB355 (effective Oct 1, 2013 - May 7,2017)

The department received 2,517 statements of claims including: 390 for domestic wells and 2,127 for instream stock.

Exempt Claim Fillings HB110 (effective May 7,2017 – May 30, 2019)

DNRC received 25,045 claims. These claims have been initially entered into the centralized water rights database and are active. We are still working on complete data entry for less than 5,000 claims. These have been hand entered by DNRC staff and have a small percentage of errors, which will be corrected during claim examination.

From July 1st, 2019 to November 30, 2019 there have been 10,631 hours spent working on HB110 claims, including examination of these claims starting in October 2019.

The claim filing period ended July 1st, 2019.
