- a draft Medicaid Section 1115 waiver application to implement portions of the Healing and Ending Addiction through Recovery and Treatment initiative for behavioral health services; and
- proposed amendments to eliminate 12-month continuous eligibility from two Section 1115 waivers that cover the Medicaid expansion population, low-income parents, and individuals with Serious and Disabling Mental Illness.

The committee also:

- reviewed changes to its draft interim work plan and adopted the work plan as revised;
- continued its informal objection to MAR Notice No. 37-949, pertaining to reimbursement rates for providers of services to people with developmental disabilities; and
- continued its informal objection to portions of MAR Notice No. 37-944, pertaining to provider rate increases for a variety of Medicaid and non-Medicaid providers, and revised the objection so it covers only maternity and optometry services.

#### WAIVER AMENDMENTS: HELP AND WASP CONTINUOUS ELIGIBILITY

#### **Overview of Proposed Amendments**

10:13:16 Darci Wiebe, administrator of the DPHHS Health Resources Division, gave a presentation on the department's planned amendment to remove 12-month continuous eligibility in two waivers: the Health and Economic Livelihood Partnership (HELP) Act waiver for Medicaid expansion and the Waiver for Additional Services and Populations (WASP) that covers low-income parents and adults with Serious and Disabling Mental Illness (SDMI). # **Revised Interim Work Plan**

#### MAR Notice 37-944, Physician Reimbursement

#### <u>Motion</u>

12:17:33 Rep. Caferro moved to continue the informal objection to MAR Notice 37-944 but modify it to include optometrists and limit the objection to physician rates only to maternity care. She would like to request that DPHHS answer questions about the proposed rule at the September meeting.
