#### **COMMITTEE ACTION**

The Committee held a videoconference meeting to discuss two proposed administrative rules related to provider rate increases: MAR Notice No. 37-944 and MAR Notice No. 37-949. After hearing a presentation by State Medicaid Director Marie Matthews, the committee voted to informally object to:

- MAR Notice No. 37-949, pertaining to reimbursement rates for providers of services to people with developmental disabilities; and
- the physician rate and policy adjuster provisions of MAR Notice No. 37-944, pertaining to provider rate increases for a variety of Medicaid and non-Medicaid providers.
