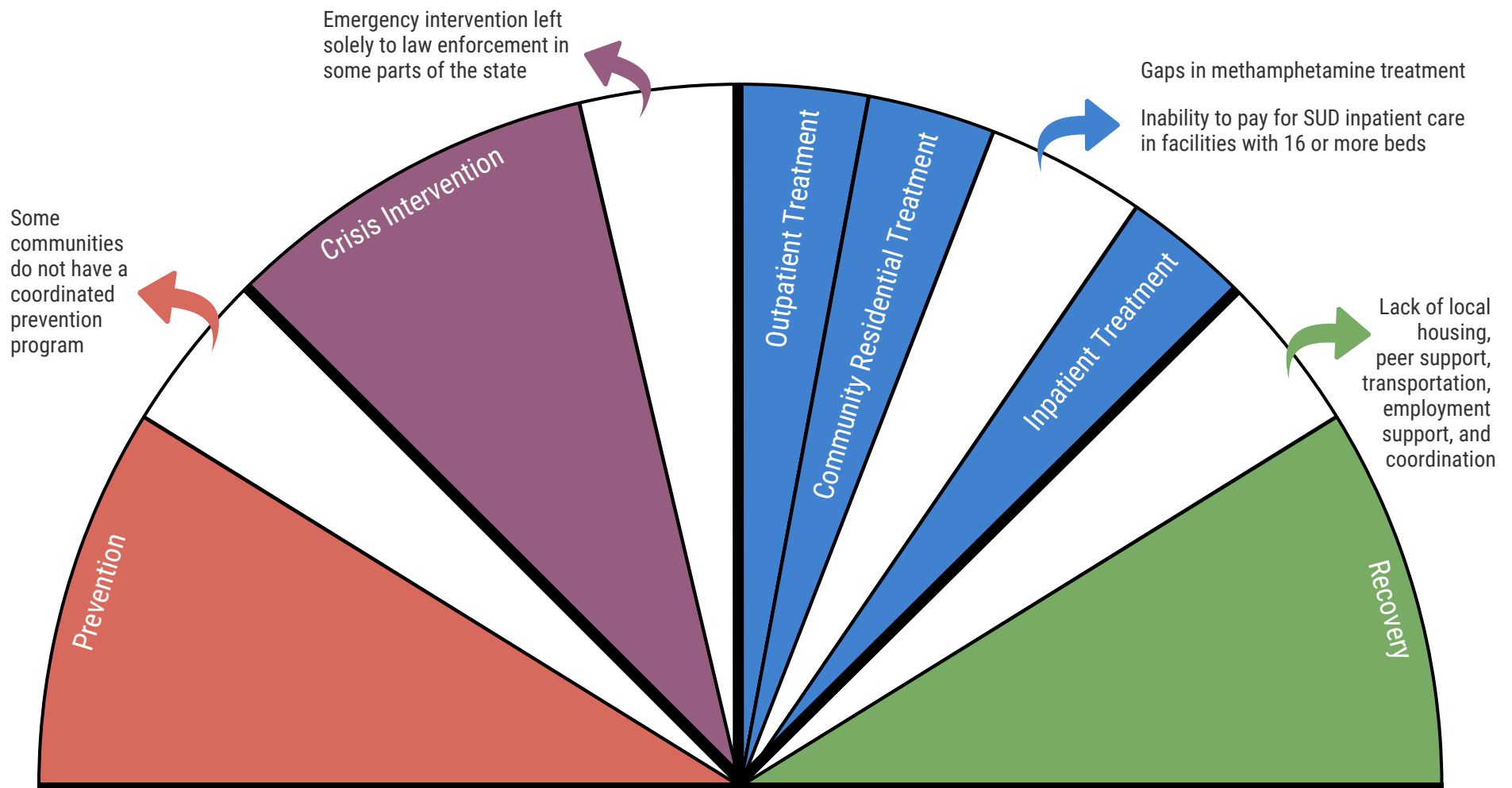

This graphic represents Montana's current model of substance use disorder (SUD) and behavioral healthcare. Gaps in the service continuum available to our local communities are represented by the missing segments in the figure below. The following pages illustrate how the Healing and Ending Addiction through Recovery and Treatment (HEART) Initiative will fill in the gaps, creating a more complete continuum of care.

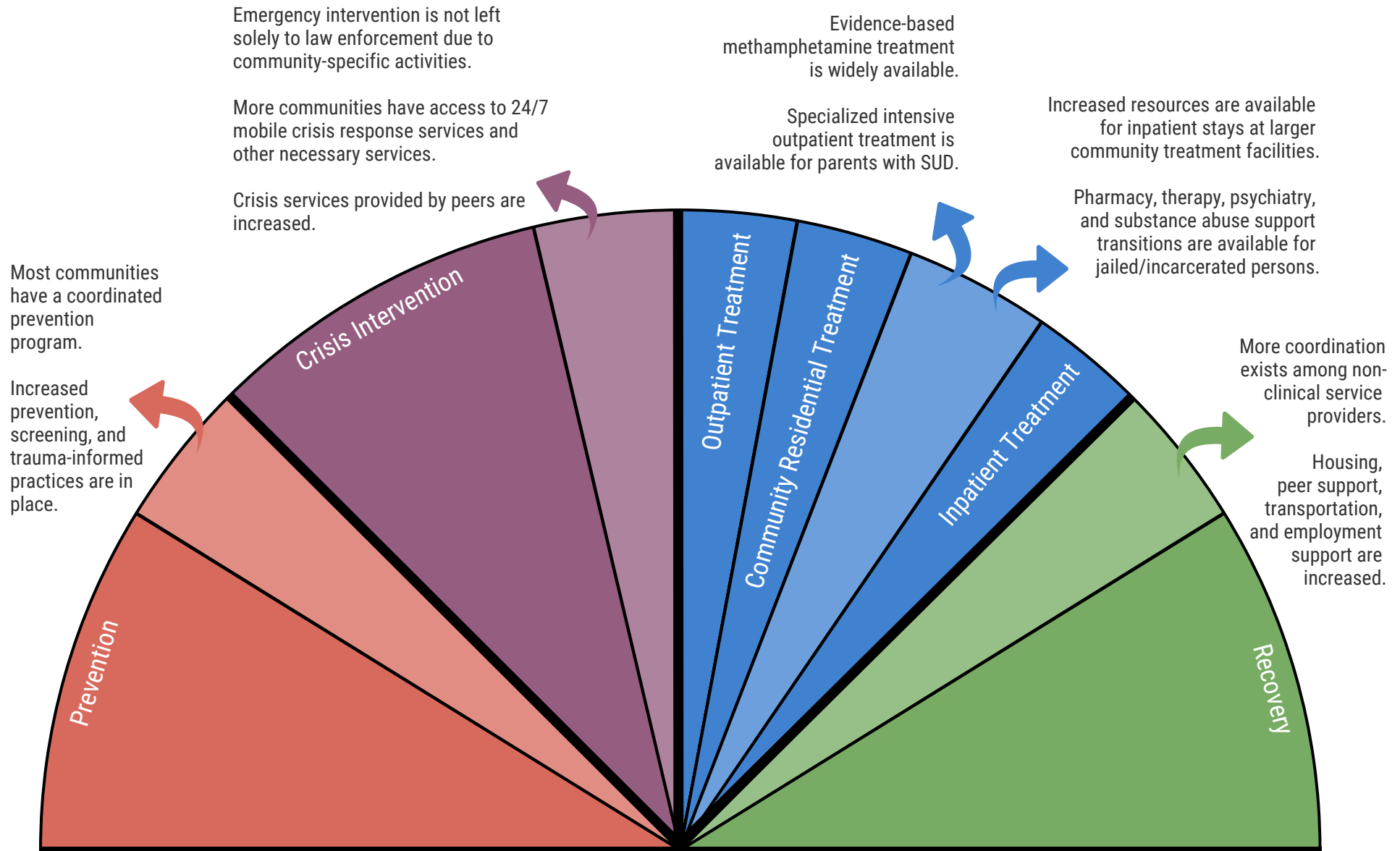
## Filling in the Gaps

Prevention	Crisis Intervention	Treatment	Recovery
<ul style="list-style-type: none"><li>Resources for community-based prevention are doubled, allowing for stronger local coalitions and more evidence-based prevention practices.</li><li>Trauma-informed prevention programs for K-3 statewide.</li><li>Targeted prevention for substance-exposed youth</li><li>Universal substance use screening for youth in schools and primary care.</li></ul>	<ul style="list-style-type: none"><li>Community-specific activities intended to decrease the strain on law enforcement.</li><li>Increased number of communities with 24/7 access to mobile crisis response services.</li><li>First responders have additional resources for training and response capacity.</li><li>Montanans in crisis have access to services close to home, including regional medical crisis hubs.</li><li>Increase in crisis services provided by peers.</li></ul>	<ul style="list-style-type: none"><li>Specialized intensive outpatient treatment for parents with SUD.</li><li>Evidence-based methamphetamine treatment.</li><li>Increased resources for inpatient stays at larger community treatment facilities.</li><li>Integrated behavioral health in primary care settings, including emergency rooms.</li><li>Pharmacy, therapy, psychiatry, and substance abuse support transitions for jailed/incarcerated persons.</li></ul>	<ul style="list-style-type: none"><li>Peer support services integrated into additional settings.</li><li>Housing, peer support, transportation, and employment support are increased.</li><li>Coordination among non-clinical service providers.</li></ul>

### HEART INITIATIVE TOOLS

- Substance Abuse Block Grant (SABG)
- HEART Fund
  - 1 Grants to jails
  - 2 Grants to Tribes
  - 3 Changes to Medicaid Benefit Plan including HEART 1115 Behavioral Health Reform Waiver

MCA 53-2-5(18) provides that a section 1115 waiver must be presented to "the children, families, health, and human services interim committee for review and comment at a public hearing prior to the submission of the proposal to the federal government for formal approval and shall also present the section 1115 waiver after final approval from the federal government."
