COMMITTEE ACTION

The committee continued work on its three mental health studies – of the publicly funded adult and children's mental health systems and of the involuntary commitment of people with dementia – by hearing presentations on the following topics:

- the reasons in-state residential treatment centers don't accept certain children, resulting in the children's placement in out-of-state facilities;
- prevention and early intervention activities being undertaken in some school districts;
- the types of individual practitioners and provider entities that serve people with mental illness, including a new provider model known as Certified Community Behavioral Health Clinic;
- the types of payment models used in the state Medicaid program;
- mental health crisis services and strategic planning for crisis services;
- recommended practices for caring for individuals with dementia who are in danger of involuntary commitment; and
- the gaps, needs, and opportunities in both the children's and adult mental health systems.

The committee also heard updates from the Department of Public Health and Human Services about the agency's activities and about proposed rules for the Comprehensive School and Community Treatment program.
