8	SERVICES; AMENDING SECTION 53-6-101, MCA; AND PROVIDING EFFECTIVE DATES."

10	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:
11	
12	NEW SECTION. Section 1. Certified community behavioral health clinics direction to
13	department. (1) Subject to available funding, the department shall establish a program no later than January 1,
14	2024, for the implementation of certified community behavioral health clinics that meet the requirements of
15	Public Law 113-93 and related federal regulations and guidances.
16	(2) A behavioral health services provider that received federal grant funding from the substance abuse
17	and mental health administration for implementation of certified community behavioral health clinics before [the
18	effective date of this act] is not precluded from participating in the program established pursuant to this section.

20	Section 2. Section 53-6-101, MCA, is amended to read:
21	"53-6-101. Montana medicaid program authorization of services. (1) There is a Montana
22	medicaid program established for the purpose of providing necessary medical services to eligible persons who
23	have need for medical assistance. The Montana medicaid program is a joint federal-state program administered
24	under this chapter and in accordance with Title XIX of the Social Security Act, 42 U.S.C. 1396, et seq. The
25	department shall administer the Montana medicaid program.
26	(2) The department and the legislature shall consider the following funding principles when
27	considering changes in medicaid policy that either increase or reduce services:
28	(a) protecting those persons who are most vulnerable and most in need, as defined by a combination

9	(c) private-duty nursing services;
10	(d) dental services;
11	(e) physical therapy services;
12	(f) mental health center services administered and funded under a state mental health program
13	authorized under Title 53, chapter 21, part 10;
14	(g) clinical social worker services;
15	(h) prescribed drugs, dentures, and prosthetic devices;
16	(i) prescribed eyeglasses;
17	(j) other diagnostic, screening, preventive, rehabilitative, chiropractic, and osteopathic services;
18	(k) inpatient psychiatric hospital services for persons under 21 years of age;
19	(I) services of professional counselors licensed under Title 37, chapter 23;
20	(m) hospice care, as defined in 42 U.S.C. 1396d(o);
21	(n) case management services, as provided in 42 U.S.C. 1396d(a) and 1396n(g), including targeted
22	case management services for the mentally ill;
23	(o) services of psychologists licensed under Title 37, chapter 17;
24	(p) inpatient psychiatric services for persons under 21 years of age, as provided in 42 U.S.C.
25	1396d(h), in a residential treatment facility, as defined in 50-5-101, that is licensed in accordance with 50-5-201;
26	(q) services of behavioral health peer support specialists certified under Title 37, chapter 38, provided
27	to adults 18 years of age and older with a diagnosis of a mental disorder, as defined in 53-21-102; and
28	(r) any additional medical service or aid allowable under or provided by the federal Social Security

- (5) Services for persons qualifying for medicaid under the medically needy category of assistance, as described in 53-6-131, may be more limited in amount, scope, and duration than services provided to others qualifying for assistance under the Montana medicaid program. The department is not required to provide all of the services listed in subsections (3) and (4) to persons qualifying for medicaid under the medically needy category of assistance.
- (6) In accordance with federal law or waivers of federal law that are granted by the secretary of the U.S. department of health and human services, the department may implement limited medicaid benefits, to be known as basic medicaid, for adult recipients who are eligible because they are receiving cash assistance, as defined in 53-4-201, as the specified caretaker relative of a dependent child and for all adult recipients of medical assistance only who are covered under a group related to a program providing cash assistance, as defined in 53-4-201. Basic medicaid benefits consist of all mandatory services listed in subsection (3) but may include those optional services listed in subsections (4)(a) through (4)(r) that the department in its discretion specifies by rule. The department, in exercising its discretion, may consider the amount of funds appropriated by the legislature, whether approval has been received, as provided in 53-1-612, and whether the provision of a particular service is commonly covered by private health insurance plans. However, a recipient who is pregnant, meets the criteria for disability provided in Title II of the Social Security Act, 42 U.S.C. 416, et seq., or is less than 21 years of age is entitled to full medicaid coverage.
- (7) The department may implement, as provided for in Title XIX of the Social Security Act, 42 U.S.C. 1396, et seq., as may be amended, a program under medicaid for payment of medicare premiums, deductibles, and coinsurance for persons not otherwise eligible for medicaid.
- (8) (a) The department may set rates for medical and other services provided to recipients of medicaid and may enter into contracts for delivery of services to individual recipients or groups of recipients.
- (b) The department shall strive to close gaps in services provided to individuals suffering from mental illness and co-occurring disorders by doing the following:
- (i) simplifying administrative rules, payment methods, and contracting processes for providing services to individuals of different ages, diagnoses, and treatments. Any adjustments to payments must be cost-neutral for the biennium beginning July 1, 2017.

2	chemical dependency facility, as those terms are defined in 50-5-101, must utilize in order to receive payment
3	from Montana medicaid for services provided to individuals of different ages, diagnoses, and treatments.
4	(9) The services provided under this part may be only those that are medically necessary and that are
5	the most efficient and cost-effective.
6	(10) (a) The amount, scope, and duration of services provided under this part must be determined by
7	the department in accordance with Title XIX of the Social Security Act, 42 U.S.C. 1396, et seq., as may be
8	amended.
9	(b) The department shall, with reasonable promptness, provide access to all medically necessary
10	services prescribed under the early and periodic screening, diagnosis, and treatment benefit, including access
11	to prescription drugs and durable medical equipment for which the department has not negotiated a rebate.
12	(11) Services, procedures, and items of an experimental or cosmetic nature may not be provided.
13	(12) (a) Prior to enacting changes to provider rates, medicaid waivers, or the medicaid state plan, the
14	department of public health and human services shall report this information to the following committees:
15	(i) the children, families, health, and human services interim committee;
16	(ii) the legislative finance committee; and
17	(iii) the health and human services budget committee.
18	(b) In its report to the committees, the department shall provide an explanation for the proposed
19	changes and an estimated budget impact to the department over the next 4 fiscal years.
20	(13) If available funds are not sufficient to provide medical assistance for all eligible persons, the
21	department may set priorities to limit, reduce, or otherwise curtail the amount, scope, or duration of the medical
22	services made available under the Montana medicaid program after taking into consideration the funding
23	principles set forth in subsection (2). (Subsection (3)(o) terminates September 30, 2023sec. 7, Ch. 412, L.
24	2019.)"
