ADMINISTRATIVE RULE REVIEW

Rule Review Procedure

14:06:42 Mr. Walker provided an update on the committee making an informal objection to Administrative Rule Notice 24-35-376, the bill implementing SB 367 from last session. Under the informal objection rule, whenever the committee meets it needs to either not continue the objection or to continue the objection. Sen. Ellsworth discussed the changes to New Rule I, License Application Renewal Fees.

- 14:07:26 Sen. Bogner said without objection, the committee will continue the objection.

Revisions to the rulemaking concerning marijuana

- 14:07:57 Mr. Walker said that at the last meeting, the committee made a recommendation that the Revenue Interim Committee (RIC) has technical rulemaking authority over the Department of Revenue's rules concerning marijuana. The committee's motion was to recommend that RIC make an informal objection to all three of the department's rule notices: 42-1033, 42-1040, and 42-1042. The RIC decided to not object and cancelled its meeting.
- 14:09:06 Sen. Ellsworth presented the Rule Revisions 12/13/2021 document. (Exhibit 1) He discussed New Rule I – License, Application and Renewal Fees; New Rule III – Marijuana Cultivator License; New Rules X through XIV – Labeling; MAR Notice 42-1042 – 42.39.117 Denial of Registry Identification Card Application or Revocation of Registry Identification Card; and 42.39.310 Waste Management; and 42.39.311 Reporting Requirements.
- 14:15:48 Sen. Morigeau discussed the New Rule III, Marijuana Cultivator License.
