- held a feedback panel on its SJ31 study on marijuana program implementation; listened to public comment; had discussion and determined next steps for the study;
- heard presentations and public testimony regarding member and emerging issues concerning:
 - domestic brewery license transfers;
 - o the Cooperative Interstate Shipment Program;
 - o the status of the Board of Horseracing lottery game implementation;
 - the home foreclosure process; and
 - Constitutional Initiative 121;
- did not renew its objection to the Department of Labor and Industry's rule on independent contractors (MAR 24-35-376); and
- voted to:
 - send a letter to the Attorney General requesting the Department of Justice investigate Whitefish Credit Union regarding potential predatory lending and unfair foreclosure practices;
 - send a letter to the Department of Revenue providing the committee's position on 16-12-223, MCA regarding existing marijuana cultivators licensees' ability to increase tiers during the moratorium; and
 - send a letter to the Revenue Interim Committee with a summary of the feedback received from the public regarding CI-121.
