Summary of Proposed Changes	The Board of Public Education adopted amendments to rules regarding the HiSET high school equivalency test. The Montana Youth Challenge Academy (MYCA) had previously been omitted from the list of programs for which a 17- or 18-year old could be enrolled in and be eligible to take the test, as well as the programs for which a participating 16-year old could receive an age- requirement waiver to take the test. OPI is no longer applying the existing "state group home" exception to MYCA, so the Board is updating the rule to ensure MYCA students are included. The Board did not receive any public comment. The changes were effective March 26, 2022.

To be eligible, a student must be at least 17 years old and incapable of completing the graduation requirements in the

district where the student is enrolled. To qualify, the student must also pass the high school equivalency test with a score at least 20% higher than the minimum passing score, complete a program with a community-based mentorship, and prepare a written plan for the student's pathway to college or career readiness that is approved by the mentor.
The Superintendent intends to adopt the rule as of June 10, 2022.
