



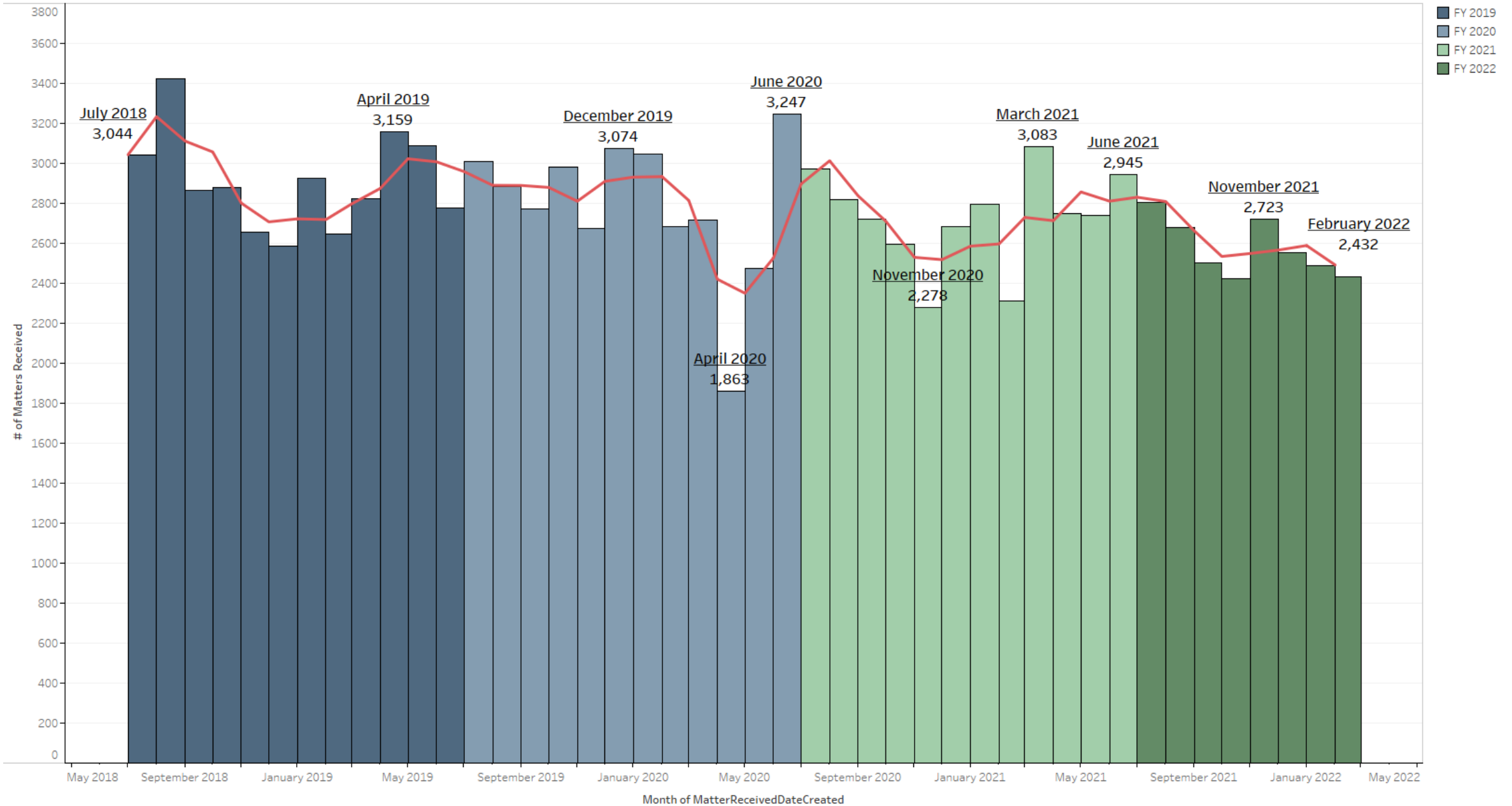

## Matters Received by Month with 60 Day Moving Average

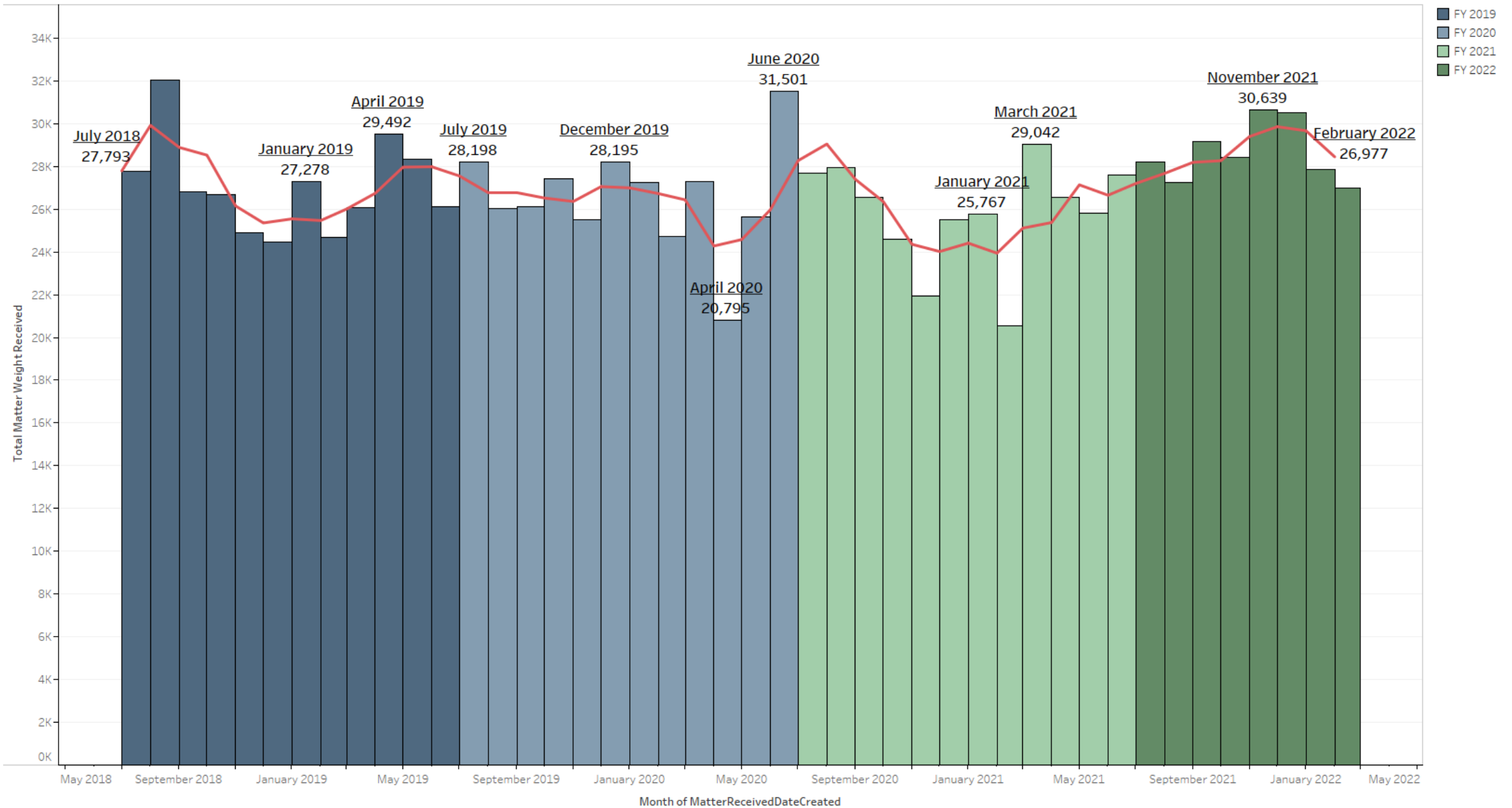
This chart displays matters received by month from FY 2019 to February 2022.

## Matter Weight Received by Month with 60 Day Moving Average

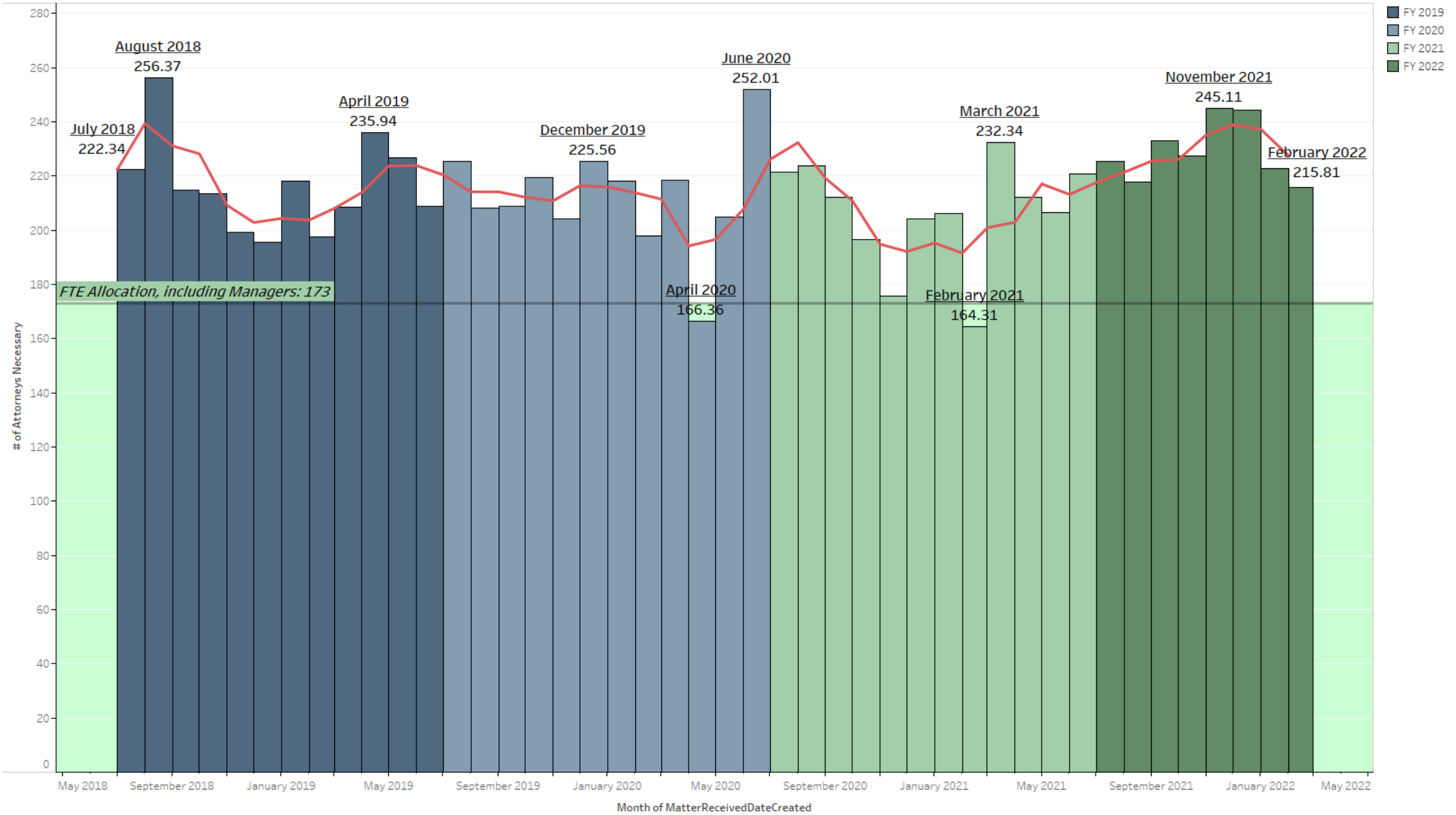
This chart displays the total weight received by month from FY 2019 to February 2022.

### Number of Attorneys Necessary for Weight Received by Month with 60 Day Moving Average

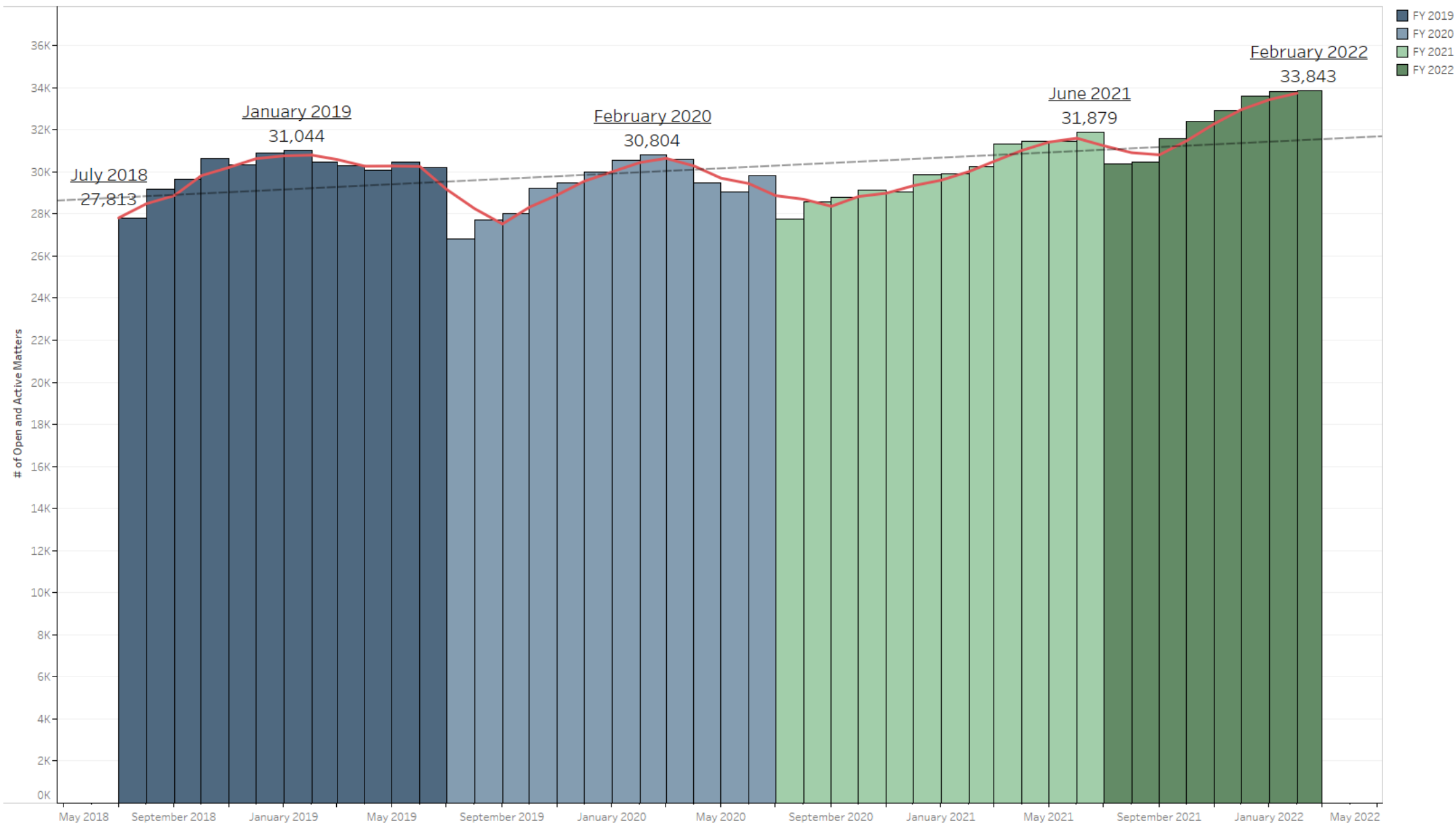

## Open and Active Matters by Month Active with 60 day Moving Average and Trend Line

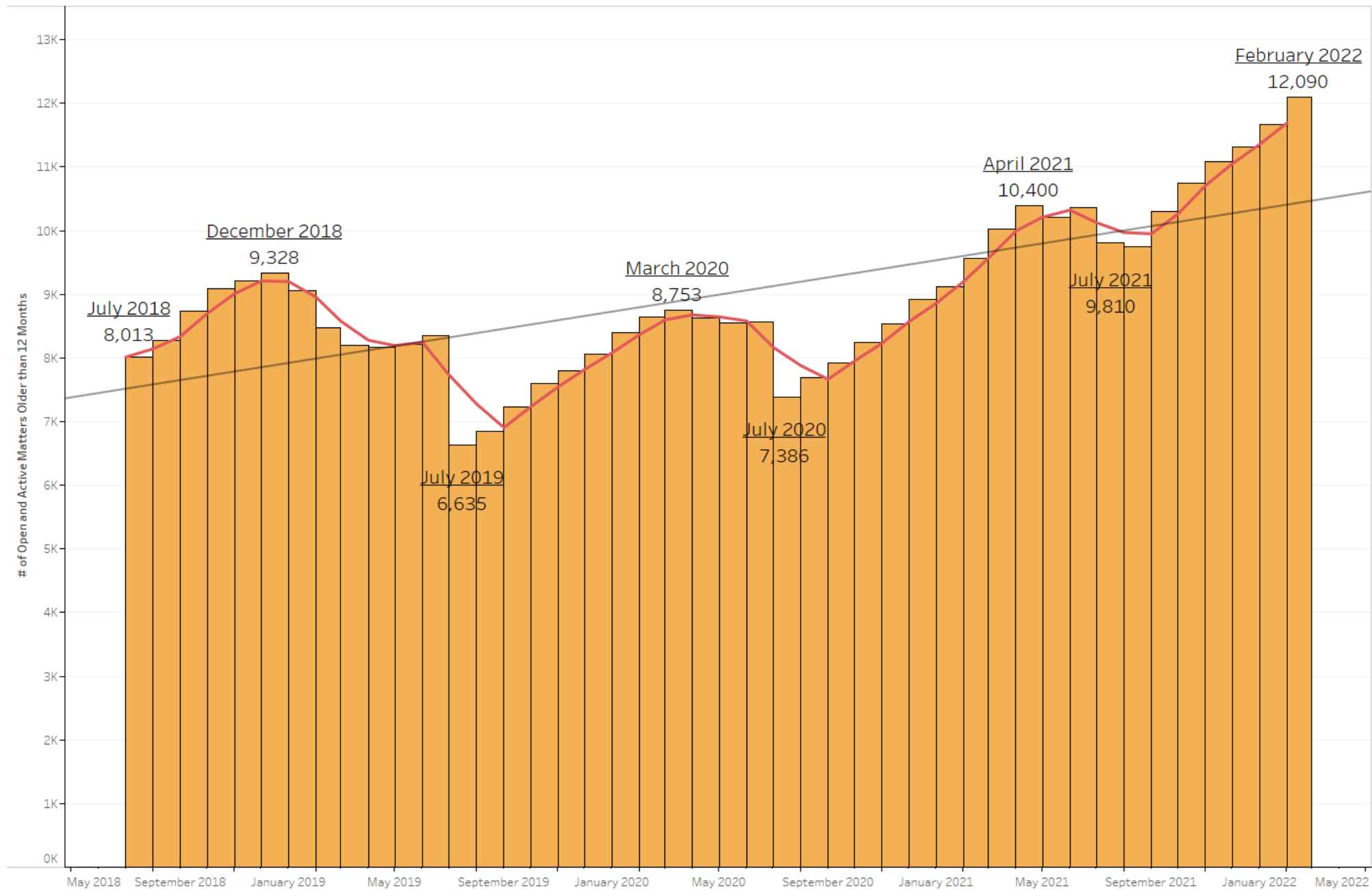
This chart displays the number of Open and Active Matters by month active from July 2018 through February 2022.

The marks are labeled by WorkingMattersWorkingDate Month and distinct count of WorkingMattersMatterID. The data is filtered on WorkingCasesWorkingReason and MatterReceivedDateCreated Month. The WorkingCasesWorkingReason filter keeps 29 of 41 members. The MatterReceivedDateCreated Month filter excludes March 2022. The view is filtered on WorkingMattersWorkingDate Year and Exclusions (MONTH(WorkingMattersWorkingDate),YEAR(WorkingMattersWorkingDate)). The WorkingMattersWorkingDate Year filter keeps FY 2019, FY 2020, FY 2021 and FY 2022. The Exclusions (MONTH(WorkingMattersWorkingDate),YEAR(WorkingMattersWorkingDate)) filter keeps 62 members.

### Open and Active Matters Older than 12 Months by Month Active with 60 Day Moving Average and Trend Line

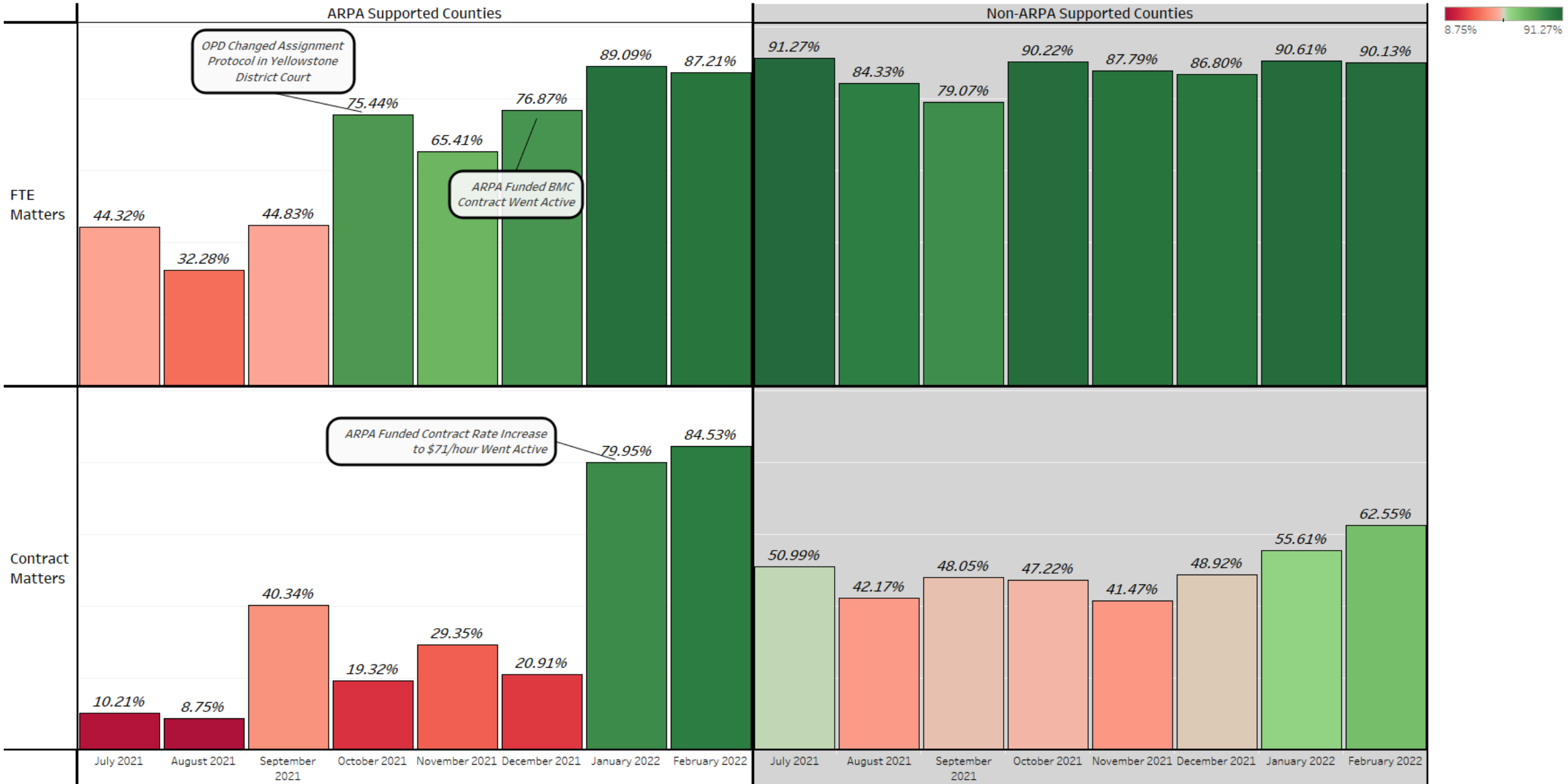
This chart displays the number of Open and Active Matters in a month that are more than 12 months old from July 2018 through February 2022.

The Defense Attorney Assignment Count filter keeps 1. The Matter Received Date Created Month filter keeps 8 members. The Matter Received Date Created Year filter keeps FY 2020, FY 2021 and FY 2022. The data is filtered on Matter Type Code, which keeps 14 of 19 members.
