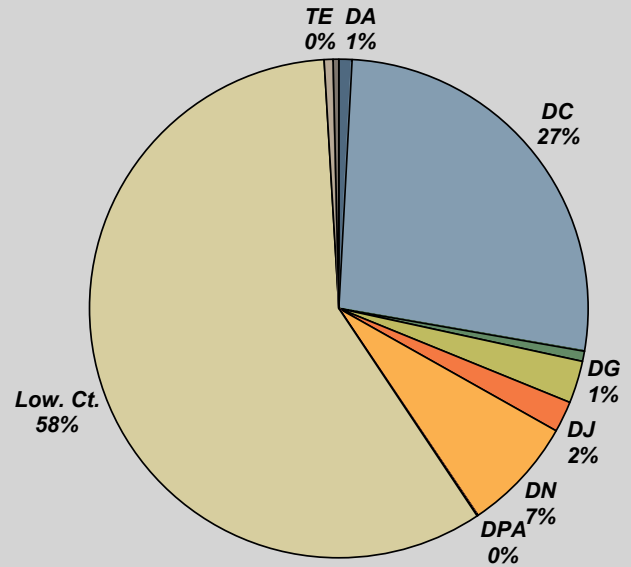

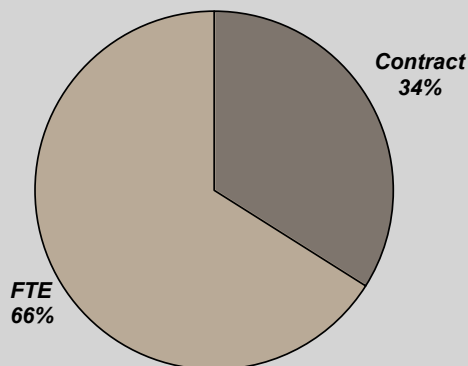
Overall Matters Received by Matter Type FY 2022

Overall Attorney Assignments by Type FY 2022

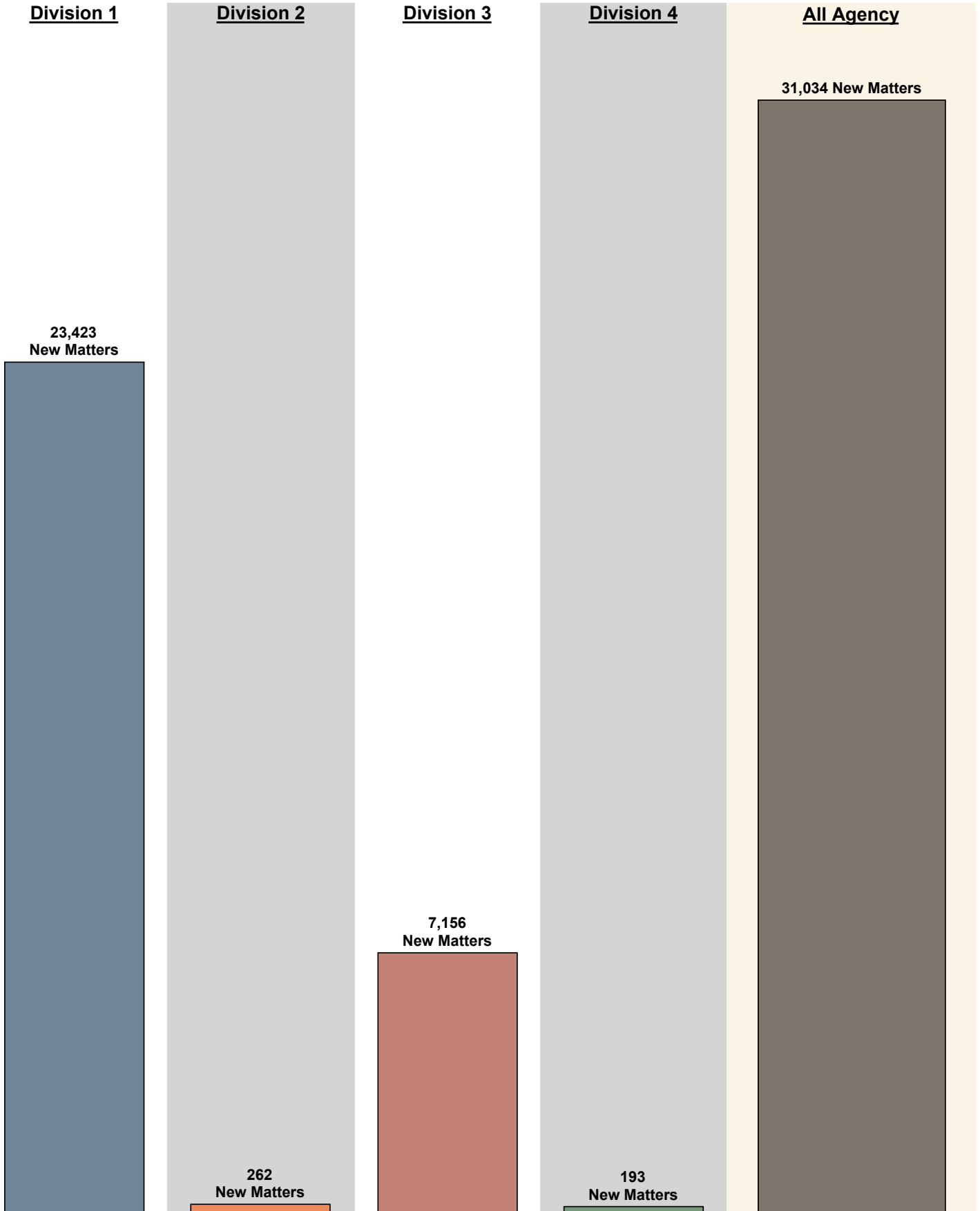

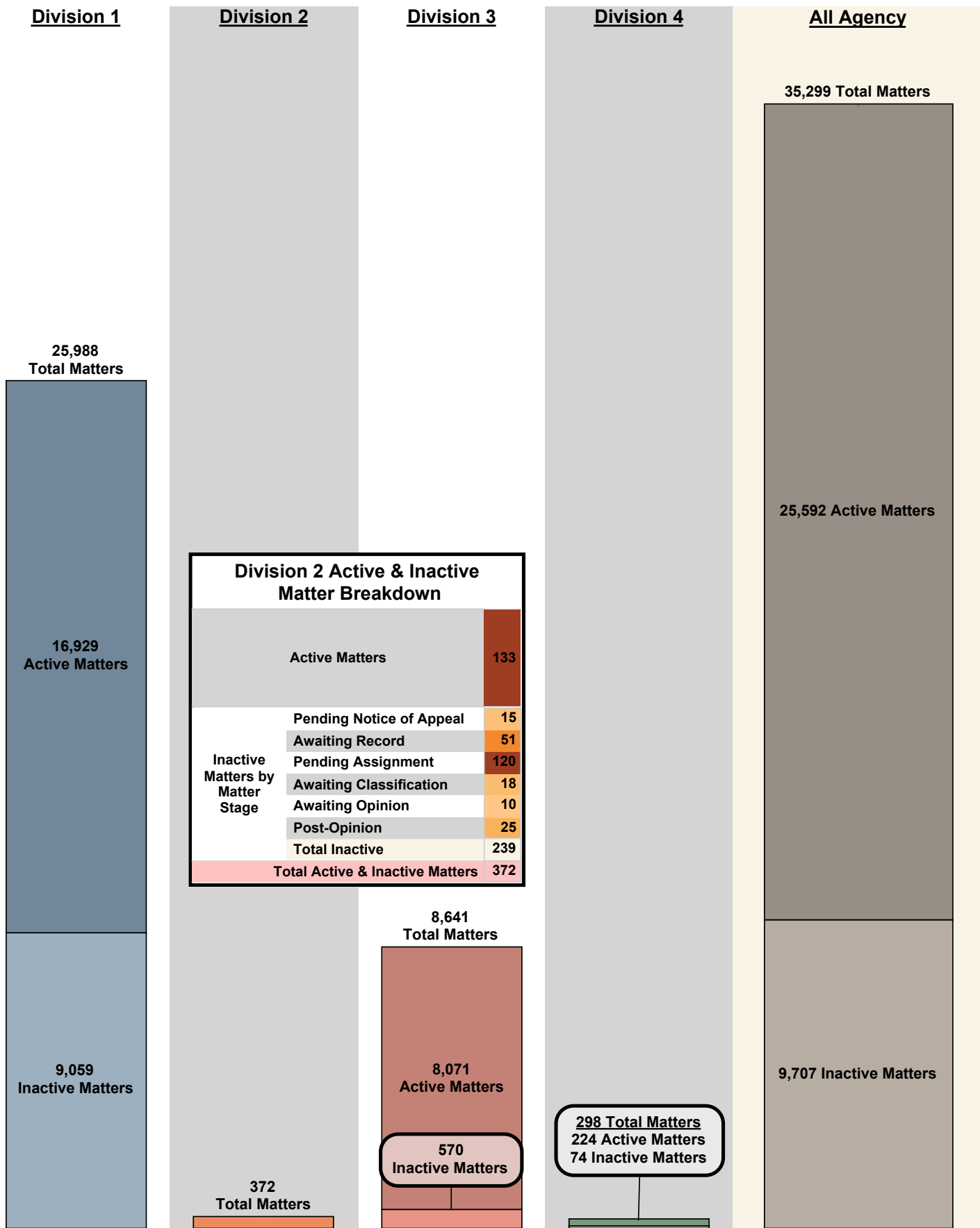
New Matters Received

This data displays all new matters received from July 1, 2021 to June 30, 2022



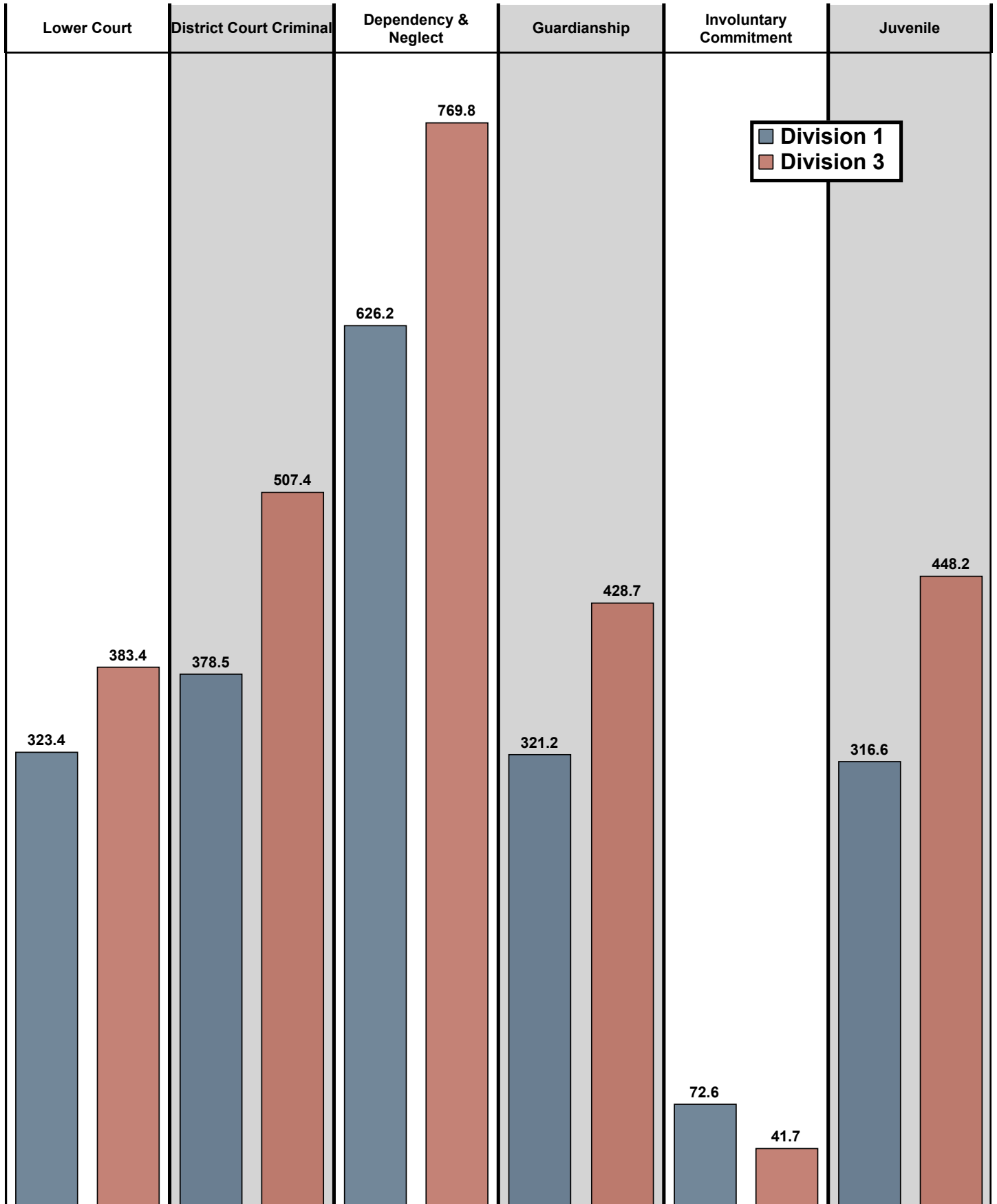
Matters by Status

This data displays matters by status as of June 30, 2022.



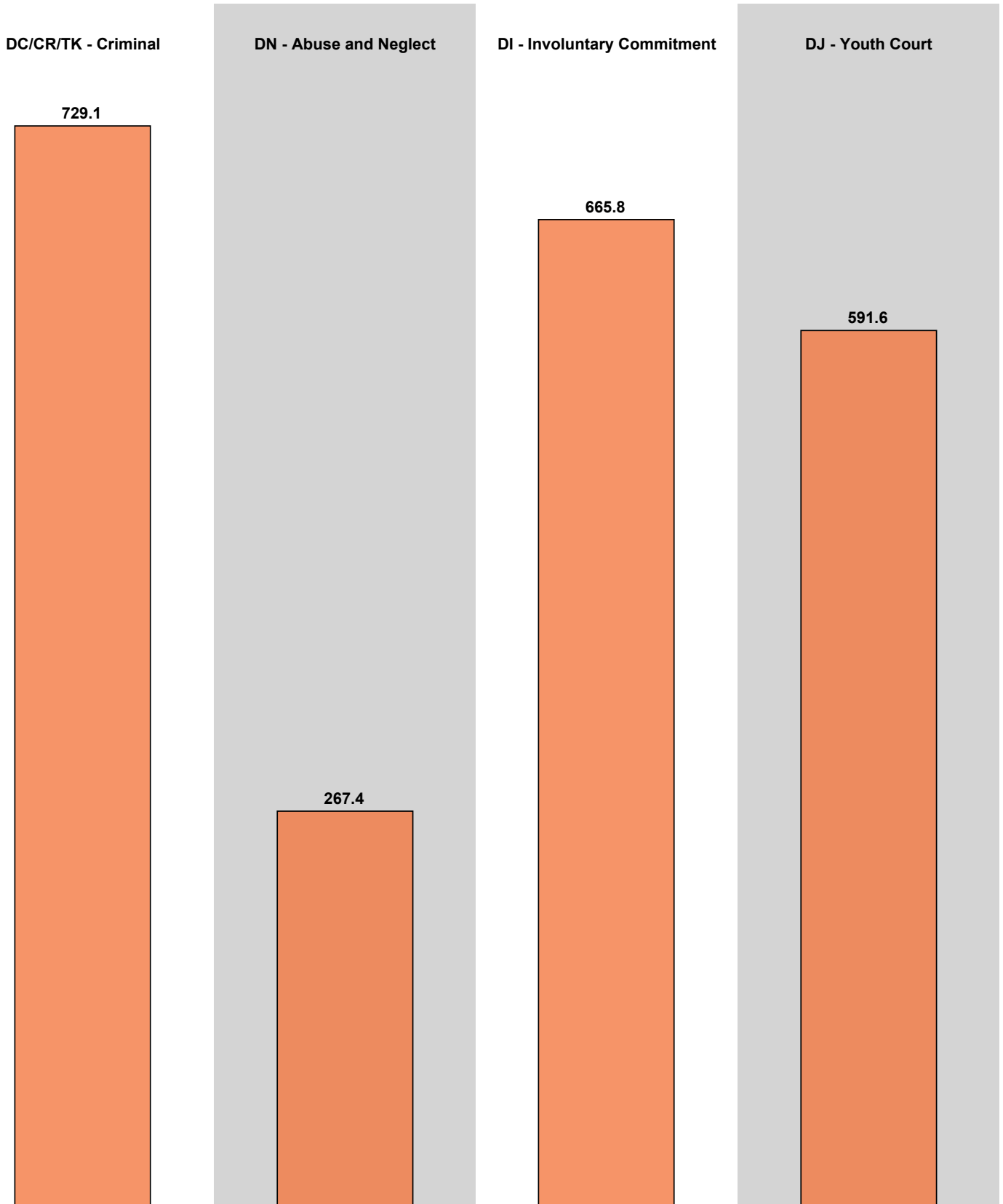
Matters Durations for Divisions 1 & 3

This data displays the average number of days matters were open before being closed in FY 2022.



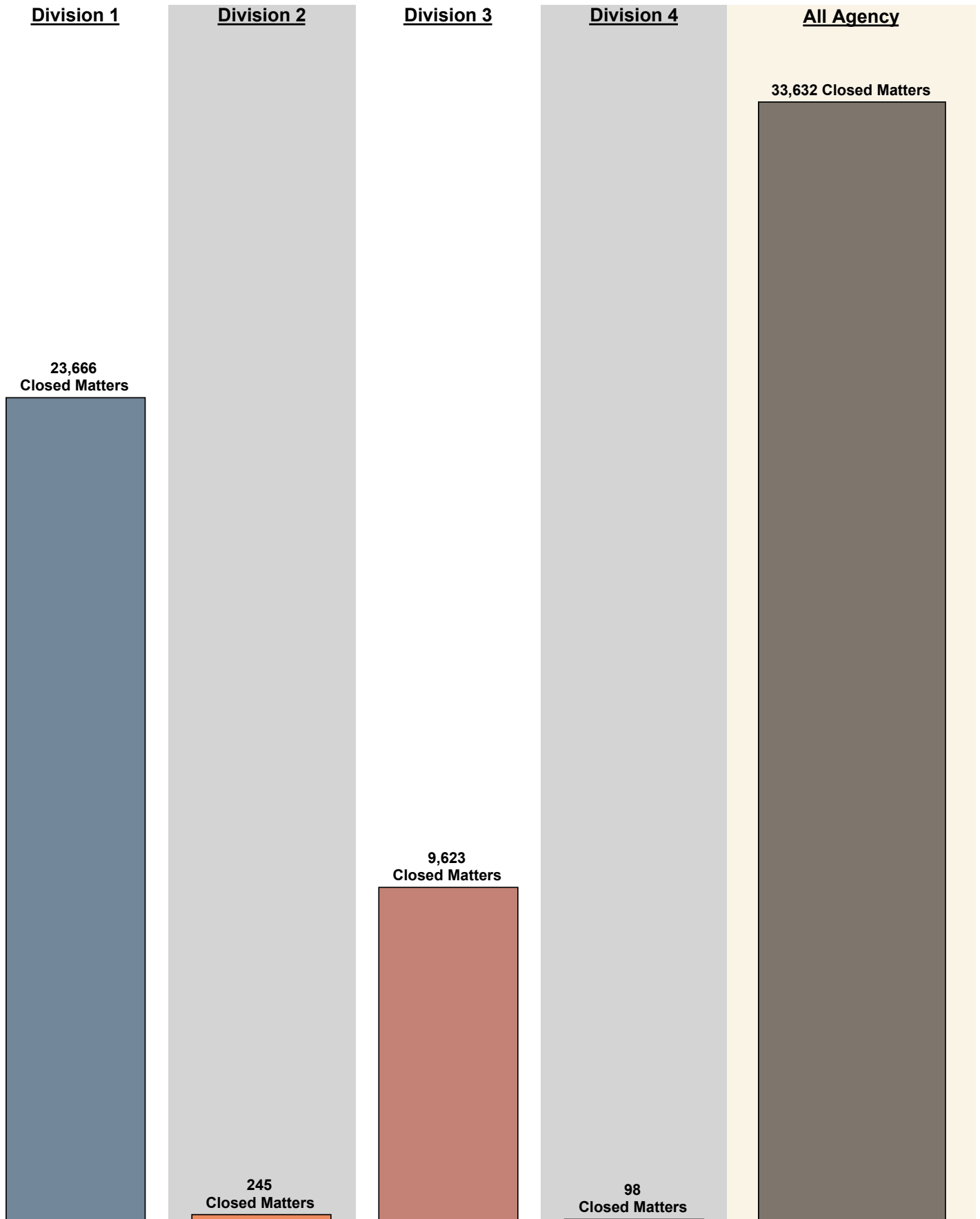
Matter Durations for Division 2
