This report is a summary of the work of the Law and Justice Interim Committee, specific to the Law and Justice Interim Committee’s 2021-2022 SB303 study of Inmate Telecommunication contracts and costs as outlined in the Law and Justice Interim Committee’s 2021-22 work plan and SB 303 (2021). Members received additional information and public testimony on the subject, and this report is an effort to highlight key information and the processes followed by the Law and Justice Interim Committee in reaching its conclusions. SB 303: STUDY OF INMATE TELECOMMUNICATIONS CONTRACTS AND COSTS

INTRODUCTION

As the Federal Communications Commission is enacting regulation to regulate interstate inmate calling rates, state lawmakers across the nation are enacting legislation to regulate intrastate inmate calling rates. Montana lawmakers examined inmate calling rates and looked at texting, emailing and video rates. The 2021-2022 Law and Justice Interim Committee members requested additional information regarding federal regulation, other state legislation and current practices in county detention centers. During the 2021 legislative session the legislature SB 303 in which requested an interim study to assess contracts and costs in state prisons and county detention centers. SB 303 resolved to:

1. Examine the current phone call rates and any ancillary fees charged by state prisons and county detention centers;
2. Review cooperative purchasing agreements to determine if counties can partner to provide telecommunications services;
3. Review methods in other states to provide telecommunications services at state and local levels;
4. Review studies to determine if inmate recidivism is lowered by continued contact with families and friends while incarcerated
5. Examine the statutory basis for the inmate welfare fund, including funding and expenditures of the fund;
6. Review federal rate caps for interstate calls from state prisons and detention centers and the effect federal law might have on telecommunication contracts;
7. Determine, if possible, the lowest cost that could be assessed to inmates in state and county facilities for phone calls; and
8. Consult with the department of corrections, county sheriffs and detention center administrators, families of incarcerated individuals and organizations advocating on their behalf, telecommunication service providers and other stakeholders.

Federal Communications Commission

These days, many people may not give a second thought to how much a phone call costs. However, for roughly two million men and women incarcerated across the country and for anyone whom they talk to, a phone call likely costs many times more because of how the calls are regulated.

The issue was raised nationally in 2003 when Martha Wright filed a petition with the Federal Communications Commission (FCC) seeking lower calling rates for calling her incarcerated grandson. The FCC is an independent U.S. government agency that oversees all interstate and international communications.

The FCC has twice set caps on inmate calling rates. A federal court struck down the first attempt in 2015. In 2021, the FCC set new inmate interstate calling rates and Montana State Prison is the only facility the new rates apply because the number of incarcerated inmates is more than 1,000 on a daily average.

FCC Inmate Calling Orders 2007-2020

Ms. Wright sought to end exclusive inmate calling services and collect-call-only restrictions in correctional facilities. In 2007 Ms. Wright and fellow petitioners filed an another petition emphasizing the urgency for the committee to act.

In 2015, the FCC issued its first permanent inmate calling order. The order limited ancillary service charges and set permanent rate caps for interstate and intrastate inmate calling services. In addition, the FCC set tiered rates caps of \$.11 per minute for prisons, \$.14 per minute for jails with average populations over 1,000, \$.16 per minute for jails with an average population of 350 to 999, and \$.22 per minute for jails having an average population of 350. In 2016, the FCC adjusted the rate caps and allowed site commission payments. Additionally, the FCC revised its tiered rates caps to \$.13 per minute for prisons, \$.19 per minute for jails with average populations over 1,000, \$.21 per minute for jails with an average population of 350 to 999, and \$.31 per minute for jails having an average population of 350.

The D.C. Circuit Court held the FCC lacked the statutory authority to cap intrastate calling service

In 2017, inmate call service provider GTL sued the FCC, and the D.C. Circuit Court struck down the permanent rate caps. The Court held that the FCC lacked the statutory authority to cap

intrastate calling service rates. The Communications Act of 1934, specifically § 276 of the act, limits the FCC's jurisdiction.

Federal Communications Commission May 2021 Inmate Calling Order

On May 20, 2021, the FCC again set rate caps for interstate inmate calling services. The order established rates at \$.12 per minute for prisons and \$.14 per minute for jails with an average population of 1,000 or more. The FCC also: 1) set a cap for site commission fees at \$.02 per minute; 2) established caps for international calling services rates at prison and jail for the first

time; 3) eliminated a higher rate cap for interstate collect calls, capped ancillary charges at \$6.95 for third-party financial transaction fees; and 4) adopted a new mandatory data collection to gather data to set future rates. The formula uses one standard deviation to the industry-wide mean to establish both a high and a low boundary of "fairly compensated." The commission also established a waiver system allowing providers to seek exemptions from the caps for any site where actual costs do not allow the company to offer services profitably.

The chart below illustrates the most populated correctional and detention facilities in Montana. Montana State Prison is the only facility subject to FCC rate caps because it exceeds 1,000 inmates. Montana State Prison amended its contract with ICS Corrections in 2021 that reduced call rates, including intrastate and interstate, in state facilities from \$.143 to \$.10, or \$.02 less than required by the 2021 FCC order.

INMATE TELECOMMUNICATION LEGISLATION AND PHONE RATES IN OTHER STATES

Arkansas – SB 550 - A.C.A § 12-29-119 – Effective April 4, 2021- Capped intrastate calls at the same rate as the F.C.C. order on January 1, 2021.

- For inmates making intrastate telephone call, the cost per min shall not be more than the maximum cost per min of an interstate inmate telephone call as determined by the F.C.C. as of January 1, 2021.
- Ancillary service charges shall not be permitted except an ancillary service charge of a type up to an amount authorized by the F.C.C. for interstate inmate telephone call as of January 1, 2021.

District of Columbia – D.C. Code § 24-263.01 – Effective April 27, 2001 – Forbids higher call rates, surcharges, and commissions as set by the DC Public Service Commission.

- No telephone service provider shall charge a customer a rate for operator-assisted calls made from a penal or corrections institution in the District of Columbia over the maximum rate determined by the Public Service Commission. The D.C. Public Commission set the maximum call rate at \$1.75 per call. 2009 D.C. PUC Lexis 95.
- No penal or correctional institution in the District of Columbia shall charge a surcharge, commission, or other financial imposition that is in addition to legally established rates for local or long-distance telephone service.

Colorado – HB 21-1201 & Colo. Rev. Stat. § 17-42-103 – Effective June 30, 2021 – Establishes a reporting requirement and a maximum per-min rate set by the F.C.C.

- The act requires penal communications service providers who provide telecommunication services to correctional facilities to maintain data and records related to the services provided to those facilities. In addition, the act requires providers to submit data and a report on the services provided to the public utility commission every quarter. The commission must publish the data and report on its website in a format accessible by the public.
- The commission shall establish a maximum per-minute rate for in-state debit, prepaid, and collect calls to or from facilities and shall conduct trial tests to ensure accountability and transparency. Starting on January 1, 2022, rate caps established by the F.C.C. apply to all in-state debit, prepaid, and collect calls to or from a facility.

SB 303: STUDY OF INMATE TELECOMMUNICATIONS CONTRACTS AND COSTS

- The act requires the commission to conduct trial tests on a statistically valid sample of penal communications services and document the test results to ensure the quality of the calls and the accountability of the service.

Connecticut SB 972, Conn. Gen. Stat. § 18-8100 – Effective June 16, 2021 – Provides free telephone calls from state facilities.

- Any such communication service shall be provided free of charge to such persons, and any communication, whether initiated or received through any such service, shall be free of charge to the person initiating or receiving the communication.
- After October 1, 2022, the state shall not receive revenue for the provisions of any communication services to any person in the custody of the commissioner and confined in a correctional facility.

Oregon - SB 498, O.R.S. § 169.683 – Effective July 1, 2019 – Prohibits Oregon Department of Corrections from receiving a fee or commission for telephone services beyond the reimbursement for associated costs. Limits call fees for local correctional facilities to 5 cents per minute and set fees for correctional facilities based on the size.

- Sets local or regional correctional facility fees or commission at 5 cents per minute.
- All calling contracts must include a stipulation that a provider submits monthly reports detailing revenue, calls made and call quality.
- Sets fee limits for local and regional correctional facilities depending on the size and bed count of the facility.

New Jersey – N.J.S.A § 30:4-8.12 – Effective August 31, 2016 – Set a rate cap at 11 cents per minute and cannot bill for call surcharges, account set up fees, bill statement fees, maintenance charges, or refund fees.

- The State Treasurer or appropriate person on behalf of the county or private correctional facility shall contract with the qualified vendor whose rate shall not exceed 11 cents per minute for domestic debit, prepaid, and collect calls and who does not bill to any party any service charges or additional fee exceeding the per minute rate, including, but not limited to, any per-call surcharge, account set up fee, bill statement fee, monthly account maintenance charge, or refund fee.
- A State, county, or private correctional facility shall not accept or receive a commission or impose a surcharge for telephone usage by inmates in addition to the charges imposed by the telephone service provider.

Utah - H.B. 219, Utah Code Ann. § 17-18a-506 – Effective July 1, 2022 – Sets specifies requirements for approving prisons phone contracts, including requirements around rates.

SB 303: STUDY OF INMATE TELECOMMUNICATIONS CONTRACTS AND COSTS

- Correctional facilities must consider the recidivism of inmates when proposing an inmate telephone rate in a new or renewed contract.
- A correctional facility may not enter into a new or renewed telephone contract unless the Civil Counsel approves the contract.

Washington State - S.B. 6476 - RCW 72.09.765 – Effective date June 11, 2020 – Establishes reporting requirement for telecommunication providers and to the governor

- Any contract to provide inmates with access to telecommunicators services must make publicly available on the department's website; a) rates; b) fees charged for money transfers; c) all fees or costs charged to inmates or customers in exchange for telecommunication services.
- By July 21 of each year, the provider shall report to the department; a) summary of services offered; b) rates charged for each type of service, including maintenance fees, transaction fees, connection surcharges, and refund fees; c) total accounting of commissions provided to Washington Department of Corrections; d) an accounting of services used by inmates; e) one-time and ongoing costs incurred for installing and maintain hardware; f) average customer response time; g) an accounting of all revenues or loss incurred by the contractor by quarter.
- By November 1 of each year, the Washington Department of Corrections shall report to the governor and legislature on contracts for telecommunications.

FEDERAL AND STATE STATUTORY FRAMEWORK FOR INMATE CALLING

Federal Law

47 CFR 64.6030 9 Effective October 23, 2020- July 28, 2021

Inmate Calling Services interim rate cap.

Link to an amendment published at [86 FR 40731](#), July 28, 2021.

No provider shall charge a rate for interstate Collect Calling in excess of \$0.25 per minute, or a rate for interstate Debit Calling, Prepaid Calling, or Prepaid Collect Calling in excess of \$0.21 per minute. These interim rate caps shall remain in effect until permanent rate caps are adopted and take effect.

Inmate Calling Services Interim Rate Caps

For all Jails with Average Daily Populations of less than 1,000 Inmates, no Provider shall charge a rate for interstate Collect Calling, Debit Calling, Prepaid Calling, or Prepaid Collect Calling in excess of \$0.21 per minute.

(b) For all Jails with Average Daily Populations of Inmates of 1,000 or greater, no Provider shall charge a Provider-Related Rate Component for interstate Collect Calling, Debit Calling, Prepaid Calling, or Prepaid Collect Calling in excess of \$0.14 per minute.

(c) For all Prisons, no Provider shall charge a Provider-Related Rate Component for interstate Collect Calling, Debit Calling, Prepaid Calling, or Prepaid Collect Calling in excess of \$0.12 per minute.

(d) For all Jails with Average Daily Populations of Inmates of 1,000 or greater, and for all Prisons, Providers may recover the applicable Facility-Related Rate Component as follows:

(1) Providers subject to an obligation to pay Site Commissions by state statutes or laws and regulations that are adopted pursuant to state administrative procedure statutes where there is notice and an opportunity for public comment such as by a state public utility commission or similar regulatory body with jurisdiction to establish inmate calling services rates, terms, and conditions and that operate independently of the contracting process between Correctional Institutions and Providers, may recover the full amount of such payments through the Legally Mandated Facility Rate Component subject to the limitation that the total rate (Provider-

Related Rate Component plus Facility-Related Rate Component) does not exceed \$0.21 per minute.

(2) Providers that pay Site Commissions pursuant to a contract with the Jail or Prison may recover up to \$0.02 per minute through the Contractually Prescribed Facility Rate Component except where the Provider's total Contractually Prescribed Facility Rate Component results in a lower per-minute rate than \$0.02 per minute of use. In that case, the Provider's Contractually Prescribed Facility Rate Component is limited to the actual amount of its per-minute Site Commission payment up to a maximum of \$0.02 per minute. Providers shall calculate their Contractually Prescribed Facility Rate Component to three decimal places.

(e) No Provider shall charge, in any Prison or Jail it serves, a per-minute rate for an International Call in excess of the applicable interstate rate cap set forth in [paragraphs \(a\), \(b\), \(c\), and \(d\)](#) of this section plus the average amount that the provider paid its underlying international service providers for calls to the International Destination of that call, on a per-minute basis. A Provider shall determine the average amount paid for calls to each International Destination for each calendar quarter and shall adjust its maximum rates based on such determination within one month of the end of each calendar quarter.

Montana State Law

53-30-153. Telephone account requirements for state prisons -- protected accounts -- disclosure required -- rulemaking -- definitions. (1) A state prison that contracts with a telecommunications service provider to provide telecommunications services for inmates shall, to the extent feasible, contract with a telecommunications service provider to provide communications services for inmates that:

- (a) provides public safety precautions required by the department of corrections;
- (b) prohibits expiration of prepaid minutes or charges;
- (c) does not charge additional usage or dormancy fees;
- (d) does not charge excessive intrastate fees that are greater than 10 cents a minute;
- (e) does not require monthly usage fees; and
- (f) allows rollover of unused, prepaid minutes into the next month unless the inmate for whom the account was set up is no longer able to use the telephone account, whether for disciplinary reasons or other reasons specified by department rule. No refund is required for unexpired minutes subject to this subsection (1)(f).

(2) Every contract entered into by a state prison for communications services under subsection (1) must require the telecommunications service provider to notify the purchaser of a prepaid telephone account of any fees or refunds that are available for unused minutes on a prepaid telephone card and mail the refund to the purchaser's address of record.

(3) The department of corrections has rulemaking authority to implement this section and shall notify the public service commission of the allowable rate that a telecommunications service provider may charge for intrastate calls under contract with the department of corrections.

(a) "Prepaid telephone account" means a system, whether purchased as a calling card or set up as an account with a telecommunications service provider, to provide telephonic connections in which the purchaser pays for minutes prior to use. The term does not include a lifeline account, defined under 47 CFR 54.401, for which a telecommunications carrier receives universal service support.

(b) "State prison" has the meaning provided in **53-30-101(3)(c)(i)** through (3)(c)(iii) and (3)(c)(v).

(c) "Telecommunications service provider" has the meaning provided for "operator service provider" in 69-3-1102.

As needed and subject to policies adopted by the local government that operates or contracts for the lease or operation of a detention center, the detention center administrator shall allow an inmate to speak on the telephone with the inmate's attorney without charge.

INMATE WELFARE FUND

The Inmate welfare fund (IWF) is an account in the state's special revenue fund used to hold money collected from phone calls and canteen purchases. At no time are the IWF funds intermingled with the DOC's general budget. Funds from the IFW are distributed among Montana State Prison, Montana Women's Prison, Pine Hills Correctional facility based on phone and canteen usage at each facility. Crossroads Correctional Facility, Dawson County Correctional Facility as well as many other county detention centers also have IWF accounts , but do not receive funds from the DOC's telecommunication contract because each of those facilities have its own communication provider.

The IWF funds are used for the benefit of inmates and their families. Items and services purchased with IWF money are not allocated through the detention facility's operating budget. Examples of purchases include recreational equipment, hobby supplies, kits for indigent inmates, release assistance, burial cost for inmates and educational materials. The DOC IWF is provided for under MCA 53-1-109.

APPENDIX B: DRAFT LEGISLATION – 8/29/22

SB 303-1

A BILL FOR AN ACT ENTITLED: "AN ACT REVISING LAWS RELATED TO STATE PRISONS AND COUNTY DETENTION CENTER TELECOMMUNICATION CONTRACTS"; AMENDING SECTION 53-30-153, MCA; SUPERSEDING THE UNFUNDED MANDATE LAWS; PROVIDING AN EFFECTIVE DATE; AND AN APPLICABILITY DATE."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

NEW SECTION. **Section 1. Detention center telecommunication contracts - definition.** (1) County detention centers that contracts with a telecommunication service provider for inmates' telecommunications may join any telecommunication contract, at the same per minute fee, as the department of corrections. A detention center may not enter a separate telecommunication contract unless the per minute fee does not exceed the current rated allowed by the Federal Communication Commission but not more then 21 cents per minute.

(2) Each week an inmate is entitled to receive one free phone call, not to exceed 10 minutes, and one free video call, not to exceed 25 minutes to the extent video calling is offered at the detention center.

(3) An inmate telecommunication contract may not include ancillary service fees including pre-paid phone cards, collect calls, and single pay calls that total more than 3% of the base charge.

(4) "Telecommunication service provided" has the meaning provided for "operator service provided" in 69-3-1102"

Section 2. Section 53-30-153, MCA, is amended to read:

"53-30-153. Telephone account requirements for state prisons -- protected accounts -- disclosure required -- rulemaking -- definitions. (1) A state prison that contracts with a telecommunications service provider to provide telecommunications services for inmates shall, ~~to the extent feasible~~, contract with a telecommunications service provider to provide communications services for inmates that:

No refund is required for unexpired minutes subject to this subsection (1)(f).

(2) Every contract entered into by a state prison for communications services under subsection (1) must require the telecommunications service provider to notify the purchaser of a prepaid telephone account of any fees or refunds that are available for unused minutes on a prepaid telephone card and mail the refund to the purchaser's address of record.

NEW SECTION. Section 3. {standard} Unfunded mandate laws superseded. The provisions of [this act] expressly supersede and modify the requirements of 1-2-112 through 1-2-116.

NEW SECTION. Section 4. Transition. The department of corrections shall include an option for a county

detention center to opt-in to a telecommunication contract at the same per-minute rate offered to the department of corrections.

NEW SECTION. Section 5. Codification instruction. [Sections 1] is intended to be codified as an integral part of Title 7, chapter 32, part 22, and the provisions of Title 7, chapter 32, part 22, apply to [sections 1].

NEW SECTION. Section 6. {standard} Saving clause. [This act] does not affect rights and duties that matured, penalties that were incurred, or proceedings that were begun before [the effective date of this act].

NEW SECTION. Section 7. Effective date. [This act] is effective July 1, 2023.

NEW SECTION. Section 8. Applicability. [This act] applies to telecommunication contracts signed or renewed by the department of corrections and county detention centers on or after April 30, 2024.
