SUBJECT: Clarification of Timing of Certain Activities of Election Administrators

NOTICE DESCRIPTION: (e.g., proposal notice/adoption notice): Notice of Public Hearing on Proposed Adoption

SUMMARY OF RULE(S):

The Secretary of State proposes to amend three rules relating to the timing of certain election administrator activities.

The Secretary of State proposes to amend one rule concerning ballots transmitted electronically by a disabled elector. The proposed amendment provides that an elector administrator must transcribe the returned ballots "[n]o sooner than the time permitted for preparation of ballots." By statute, certain ballot preparations begin no sooner than 3 days before election day, although an exception is provided, limiting the processes in certain small counties to 1 day before election day. This rule would apply those statutory timelines concerning absentee ballot preparation to electronically transmitted ballots by disabled electors. Staff has requested that the Secretary of State clarify whether the proposed amendment intends to apply also to the timeline for the small county limited exception because of ambiguity in the cross reference. The Secretary of State has agreed and will update the cross reference appropriately so that the small county exception is included.

The Secretary of State proposes to amend one rule concerning the procedures for the preparation

of absentee ballots. The proposed amendments update references to the early preparation and counting of ballots beginning as specified in statute, rather than the preparation beginning 1 business day before election day and counting beginning on election day. The previous provisions concerning preparation and counting were superseded by changes in Chapter 229 (2019) that revised the timelines for handling and tabulating absentee and mail ballots. The proposed amendments also updated appropriate cross references.

Likewise, the Secretary of State proposes to amend one rule concerning the electronic transmission of voting materials to covered voters to state that the election administrator shall have the returned ballots transcribed no sooner that the time permitted for preparation of ballots as provided in statute.

NOTES: A public hearing will be held at 10 a.m. on August 12, 2022, in the Secretary of State's Office Conference Room, Room 260, State Capitol Building, Helena, Montana. The public comment period ends on August 19, 2022.
