RE: Administrative Rule Report – July 11, 2023

This report summarizes administrative rules proposed or soon to be proposed by the Department of Public Health and Human Services (DPHHS), and rules adopted by DPHHS after the Legislature adjourned on May 2, 2023. MAR Notice Number: 37-1033

<u>Subject:</u> Chemical dependency programs and Medicaid mental health services

Proposal Notice to be Published: July 21, 2023

<u>Summary:</u> The Department is proposing permanent updates to allow telehealth delivery of identified services, discretion related to staffing, and clarification of utilization requirements for identified services. The Department proposes to adopt updated versions of the Behavioral Health and Developmental Disabilities (BHDD) Medicaid and non-Medicaid manuals to effectuate these changes. The updated manuals will be available at https://dphhs.mt.gov/bhdd/. The proposed effective date for the updated manuals is May 12, 2023.

<u>Notes/Hearing</u>: A public hearing is scheduled for August 11, 2023. Public comment is due August 18, 2023.

MAR Notice Number: 37-1036

Subject: Developmental Disabilities Program Reimbursement for Services

Proposal Notice to be Published: July 21, 2023

<u>Summary:</u> The Department is proposing to amend ARM 37.34.3005 to incorporate updates to the Montana Disabilities Program Services Manual. The changes in the manual pertain to reimbursement rates for the Montana Disabilities Program Services and to changes to conform

the manual to Developmental Disabilities 0208 Comprehensive Waiver approved by CMS as part of the waiver's routine five-year renewal process.

- Reimbursement rates: The Department is proposing to apply funding appropriated by the 2023 legislature across all studied rates in the Developmental Disabilities Home and Community-Based Service Waiver Program using the methodology recommended by Guidehouse. The methodology will increase rates by a percentage of the difference between current rates and benchmark rates. The Department will fund about 70% of the gap between the current rate and the benchmark rate, bringing rates up to 94% of the Guidehouse benchmark effective July 1, 2023. This results in an increase of approximately 18%. The specific rate increase for each service is dependent upon the difference between the current rate and the benchmark rate. The proposed rates can be found on pages 63-65 of the draft Developmental Disabilities Program Services Manual. The updated manual will be available at: https://dphhs.mt.gov/bhdd/DisabilityServices/developmentaldisabilities/ddpratesinf.
- Additional changes: The updated manual adds telehealth language to services eligible for telehealth; adds legally responsible individuals as allowable paid caregivers; updates definitions to be consistent with the CMS-approved 0208 waiver; adds transportation language to services eligible for transportation in the legislatively approved rates; adds additional tiers for BSS service to be consistent with CMS-approved 0208 waiver; adds prorating language; and adds retainer payments for certain services to be consistent with CMS-approved 0208 waiver.

The Department intends the proposed rule amendments to apply retroactively to July 1, 2023. Notes/Hearing: A public hearing is scheduled for August 10, 2023. Public comment is due August 18, 2023.

<u>Subject:</u> Emergency Medical Services

Proposal Notice Published: July 7, 2023

<u>Summary:</u> The Department proposes this rulemaking to update, consolidate, simplify, and make more user friendly, the administrative rules governing licensure of emergency medical service providers. The proposed rulemaking repeals the existing 43 rules governing emergency medical services and adopts 14 new rules in their place and incorporates and adopts by reference a new Emergency Medical Services Appendix. Subject: Medicaid Home and Community Based Services Program

Proposal Notice Published: July 7, 2023

<u>Summary:</u> The Department proposes this rulemaking to amend ARM 37-34-907, which pertains to the selection and entry in the Home and Community Based Services (HCBS) Waiver. The

proposed amendment allows persons on the HCBS Waiver waiting list who are at risk of institutionalization due to the insufficiency of non-waiver services, an emergency reserved capacity slot. The threat of institutionalization meets the emergency criteria approved by the Center for Medicare & Medicaid Services (CMS) on April 21, 2022.

<u>Subject:</u> Updating Medicaid and Non-Medicaid Provider rates, fee schedules, and effective dates <u>Proposal Notice Published:</u> July 7, 2023

Summary: The Department is proposing to amend ARM 37.69.326, 37.85.104, 37.85.105, 37.85.106, and 37.86.3607 to update Medicaid and non-Medicaid provider rates, fee schedules, and effective dates. When the notice is published in the MAR, proposed changes to provider rates that are the subject of this rule notice, including rates in fee schedules and rates in provider manuals, should be available at https://medicaidprovider.mt.gov/proposedfs
In brief, the Department proposes

- for the four areas studied by Guidehouse during the 2021-22 interim (Adult Behavioral Health, Children's Mental Health, Developmental Disabilities, and Senior and Long Term Care programs), to increase rates by funding about 70% of the "gap" between the current rate and the Guidehouse benchmark rate and bring these rates up to an average of 94% of the Guidehouse benchmark, effective July 1, 2023. This will result in an increase in funding of approximately 18%, effective July 1, 2023. The specific rate increase for each service is dependent upon the difference between the current rate and the Guidehouse benchmark rate.
- a weighted average rate increase of 4% for provider rates not studied by Guidehouse.
- to add mobile crisis services for both the Medicaid and non-Medicaid programs
- to remove outdated references to the department's physical address but to maintain links to the agency's website as the method for obtaining or viewing fee schedules and manuals adopted by reference in the rules
- to update the HMK Dental fee schedule to align with the state employee benchmark plan
- to adopt the Resource-Based Relative Value Scale (RBRVS) contained in the Medicare Physician Fee Schedule adopted by CMS in the November 18, 2022 Federal Register and update applicable conversion factors to result in a weighted average rate increase of 4% for allied services and mental health services
- to set the payment-to-charge ratio to 46.8%, effective July 1, 2023
- to change the optometric services provider rate of reimbursement to 115.50% of the reimbursement for allied services with an effective date of July 1, 2023, which is a weighted average provider rate increase of 4%, consistent with the weighted average rate increase for providers not included in the Guidehouse study
- to adopt the Outpatient Prospective Payment System (OPPS) fee schedule published by CMS in the November 23, 2022, Federal Register
- to increase the OPPS conversion factor to \$58.39, effective July 1, 2023
- to update the Medicaid statewide cost-to-charge ratio to 48.95%
- to increase the bundled composite rate for outpatient maintenance dialysis clinics by 4% to \$271.02 effective July 1, 2023

- to adopt fee schedules effective July 1, 2023 to incorporate changes due to the proposed amendments in this notice, including federal register changes, conversion factor update, and legislatively required provide rate increases
- to update the dental approved provider rates, dental procedure codes, and dental provider manual
- to update the outpatient drugs dispensing minimum fee to \$5.11 and increase the maximum dispensing fee to the legislatively approved provide rate increase
- to increase the fee paid for each additional vaccine administered to \$18.65 to align with the physician services rate
- to adopt and incorporate by reference the Medicare Region D Supplier Manual effective July 1, 2023 and revise the effective date for the durable medical equipment fee schedule to July 1, 2023
- to adopt updated fee schedules for senior long term care effective July 1, 2023
- to adopt updated fee schedules for behavioral health and developmental disabilities division effective July 1, 2023
- to update the Medicaid youth mental health services fee schedule to incorporate legislatively approved provider rate increase and change effective date to July 1, 2023
- to update the effective date of the Medicaid Behavioral Health Targeted Case Management Fee Schedule to July 1, 2023
- to increase provider rates for Targeted Case Management Services for Individuals with Developmental Disabilities Enrolled in the 1915(c) 0208 Home and Community Based Comprehensive Waiver for Eligible Individuals Age 16 and over by adopting and incorporating an updated version of the manual dated July 1, 2023
- to amend 37.87.1226(1) to align in-state and out-of-state reimbursement rates for psychiatric residential treatment facility services

<u>Subject:</u> Nursing Facility Reimbursement <u>Proposal Notice Published:</u> July 7, 2023

<u>Summary:</u> The Department proposes to set the flat rate component for Medicaid nursing facility reimbursement at \$257.54 for SFY 2024, which equates to a 23.02% rate increase from SFY 2023. The Department intends to retroactively apply the amendment to July 1, 2023.

<u>Summary:</u> DPHHS is proposing to amend ARM 37.34.1902 to expand the list of persons who are eligible to establish a qualifying diagnosis for the continuation of ABA services after an initial 180 days of allowed services and to adopt and incorporate into rule updates to the department's Applied Behavior Analysis (ABA) Manual (available at

https://medicaidprovider.mt.gov/manuals/appliedbehavioranalysisservicesmanual) dated July 1, 2023.

Subject: Hospice Reimbursement

<u>Summary:</u> The department proposed to amend ARM 37-40-802 to update references to the federal regulations to the most current version of the Code of Federal Regulations and to amend ARM 37.40.830 to update the Medicaid hospice reimbursement fee schedule reference to the rate set by the Centers for Medicare & Medicaid Services (CMS) in the Federal Register effective October 1, 2022.

<u>Summary:</u> The department proposed to change all references to the Low Income Energy Assistance Program (LIEAP) to the Low Income Home Energy Assistance Program (LIHEAP), to update the benefit award matrix for use during the 2022-2023 heating season, to amend eligibility related household income assessments; to use 2022-2023 poverty guidelines for eligibility determinations and other changes to adjust for inflation; and small grammatical and organizational changes throughout for clarification.
