See §§ 2-4-302 and 2-4-305. Rulemaking is adopted upon filing the adoption notice with the Secretary of State and effective upon publication of the adoption notice in the MAR. See 2-4-306, MCA. The Secretary of State publishes the MAR two times a month. An agency must file notices with the Secretary of State's office at least 10 days before publication in the MAR. See ARM 1.2.419.
