### BACKGROUND

#### THE TRANSITION REVIEW COMMITTEE

<u>Senate Bill 352</u>, introduced during the 2023 Legislative Session, established a work group to modify and improve child protective services in Montana. The work group is attached to the Children, Families, Health, and Human Services Interim Committee.

### PLANNING YOUR WORK

#### **WORK PLAN**

A tool for the work group, its staff, and the public.

SB 352, SUBSECTION (2) directs the work group to investigate and report to the interim committee on topics including but not limited to:

- (a) the removal of children from homes;
- (b) centralized intake reports and procedures;
- (c) investigations of reports of abuse and neglect;
- (d) the potential for family support to help prevent removal of children or expedite reunification;
- (e) foster care;
- (f) kinship care;
- (g) the interaction of child protective services with the judicial system;
- (h) department of health and human services policies and procedures;
- (i) reunification of children with their families of origin; and
- (j) topics related to the Indian Child Welfare Act.



The Children, Families, Health, and Human Services Interim Committee has 0.2 FTE (full time equivalent) from its research analyst. Part of that 0.2 FTE is used for this work group. Reports and presentations by state agencies or other entities require staff time to organize and process. Administrative work, including placing requests for information and drafting committee communications and reports, also requires staff time.
