There is so much wrong with Mt in terms of CJO. I have been a voice for much as early as 2010. However it's not been without cost to me in all areas of my life. I am talking about retaliation from DOC. It started with my reporting PREA. Now Jim Patelis can tell you I told the truth. But up until Sept 2017 DOC called me a liar. I was emotionally tortured while incarcerated until 2014 and then harassed by the Polson PP office. I've been laughed at both to my face and behind my back. I've had officers at the women's prison call me crazy. I've had official reports done by Warden Hansen herself which claimed I never worked for the USCG. Which has been proven wrong. I've had hundreds of dollars in Hobby supplies stolen at the direction of DOC employees. These were men and women who worked for the State of Mt. They were paid by the state of mt to harass me! I am being harassed by DOC now. Facing a revocation for talking to Offenders. The state AG has spend significant time in court over 4 hrs to ask over 100x 1) if I was a real advocate 2) if I held a degree in advocacy 3) work for a any non profit. He wants to make sure the judge sees me as a wacko just out to say stupid shit. Of course it wasn't mentioned about my full discrimination findings, my anti PREA work or the years of attending many many many hearings mtgs and such. I've been on conditional release for many yrs. I was found guilty of TALKING TO OFFENDERS. The amount of money the MT DOC spent to find me guilty of this is remarkable. I also know while on conditional release there are so many emails between DOC and the parole board it would cost me a small fortune to get them. There must be something they definitely don't want me to see. My better question is why do these emails exist? Because I was on probation then conditional release. DOC and BOPP would have no reason to discuss me at such length. My attorney says the state is wants jail time. FOR TALKING TO OFFENDERS? One of the questions the AG asked Of it's own witness was "is it true she was hard to control while on supervision"? only place that could have come was DOC and why was it asked? It had nothing to do with the matter at hand. That is what told me DOC was behind the matter. It was also filed the day after the session ended. Not a coincidence. And I am not the only one who thinks that. Members of this very committee think the same thing. I pled guilty of talking to offenders. I get dozens of calls a week from family. DOC has cut my access to speaking to offenders but their families contact me. I am sure the prosecutor thinks that's wrong too. THEY ask me all kinds of things. Report all kinds of thinks. I was contacted by family this

weekend over the conditions in AZ because people were told it was voluntary but it wasn't. They took on man from Deer Lodge who was saving DOC over 7000 a yr because of skills at auto repair and forced him to go to AZ. where they were shackled for 30 with no rest room breaks. Where they will loose the tablet availability. Where he had to toss away a \$200 pair of work books. Where canteen went from %1.50 a back of coffee to over \$7 + tax. And there are no jobs. I am mounting one hell of a defense at the sentencing. Do you realize that a revocation can be based on hersay? The rules of evidence don't apply? I plan on showing the letter from my 2010 State appointed District court lawyer where he admits he didn't do his job and alot more. Like Jail corruption at my sentencing and a witness who was committing insurance fraud not known till my parole in 2014. But I have made the decision, should incarceration be ordered, I plan on ending my life. Now don't worry about me. Several on this committee have heard me say this already. My therapist knows. My attorney knows. My friends know. I am done being the victim of DOC malicious when I thought ending rape of inmates was the right thing. And ending discrimination is the right thing. Or working my ass off to make Mt safer was the right thing. Lowering incarceration rates is the right thing. Or telling all of you, the committees both current and who have come before re entry has to be addressed or Mt will never move forward. Because fixing the magic system isn't just about building bigger prisons. It's about families, communities becoming healthy, drug free, economically vibrant, supporting local businesses.

To the Members of the Montana Criminal Justice Oversight Council,

My name is Stephanie (Houchins) Mollet. When I was 12 years old, my older sister was murdered outside of Belgrade, Montana. I am writing to you because I'd like to ask for your help in finally solving my sister's murder. To bring justice for the death of a 15-year-old girl. To ensure that the person who did this to Danni cannot do this to others.

On September 21, 1996, 15-year-old Danielle (Danni) Houchins went out to Cameron Bridge Fishing Access by herself and didn't come home on time. After an extensive Search & Rescue operation, spearheaded by Gallatin County SAR and involving many family, friends and community members – Danni's body was found. She was face-down in a shallow amount of marshy water. She was covered in mud. Danni was dead. It devastated my family. It can be hard to describe the feelings. Beyond shock. Beyond confusion. Our family had moved to Montana just a couple years before. Danni had a lot of friends. She was kind. She was generous and accepting of people who they were. She had a quick wit and infectious sense of humor.

The autopsy would show that Danni's cause of death was asphyxiation, due to the large volumes of water and mud in her esophagus, and all the way down in her lungs. Someone had held her head down in the marsh, until she died. There was subcutaneous bruising on the back of her neck, indicative of a hand pushing her head down. Her body had been dragged. Her sandal was found about 25 feet from her body. Her left arm was extended up above her head, and her watch was pulled up over her thumb and hand. There was evidence of sexual violence. Though her body had been dragged, her bra was rolled up above her breasts, underneath her sweatshirt. Her panties were oddly rolled and folded, underneath her jeans. There was semen in her panties.

Despite all this evidence, law enforcement classified Danni's manner of death as "undetermined". The Gallatin County Sheriff's Office investigated for a few months, but for all accounts, did not take Danni's death nearly as seriously as they should have. A few years later, an interested detective took up the case, and repeatedly met roadblocks within her own department, limiting her ability to successfully solve Danni's murder. In 2020, a new detective reached out to me and my family, as he had re-opened the case. Not only was Danni failed by law enforcement in 1996, but repeatedly over the last 27 years since her murder.

In 2020 – 24 years after Danni's murder – the GCSO re-opened Danni's case. It's been over 3 years since investigators have been dedicating resources to finally solving Danni's case. But they're meeting roadblocks, severe roadblocks, with the State Crime Lab's bandwidth and ability to test the forensic evidence from Danni's case. While I can empathize with the demands of a growing community and working with limited resources – it's no excuse for not seeking justice

for the murder of a 15-year-old girl. I am afraid that Danni will be forgotten again, evidence from her case will be shelved, and she will never receive the justice she deserves.

I cannot stand by and allow Danni to be forgotten again. There's only so much that investigators can do with the circumstantial evidence in Danni's case, without the forensic side of Danni's case making progress. Your State Crime Lab needs resources, so they can work through their backlog of cases that need solving. Though a cold case is often deprioritized for current case and trial needs when resources are tight – I can promise you that the cold case is never "cold" for a family.

I need your help in these efforts. Please work to fund the State Crime Lab so they can drive justice for victims all over the State of Montana. Innocent victims like my 15-year-old sister. You can help make a difference for families of victims and communities devastated by senseless murders. You can help ensure that the person who murdered Danni doesn't have an opportunity to continue hurting Montana women.

The ticket says Dec 7th, 2023. I just attempted to access my google account to see if the video was there as I was going to send it to the court and the MPD. It is now missing. I believe Anne Marcum has my phone in her possession and has since deleted the video. Please look into this matter as soon as possible. One of the criminals with a badge could be a Deputy Shultz, his partner is a deputy Shu. They are still continuing to harass me and threaten my life. It is my belief that the water at the Warming Shelter may have been poisoned. It is also my belief that they tortured my poor little dog Monkey. I loved this dog like a child. They had also killed my dog Froggy. Stolen from my parents yard by their neighbors Cathy and Mike. Richard or Rori Sherman/Mcelderry or Wilson. I am at a loss. These evil monsters still torment me now at the warming shelter in Missoula. 6. They have been following me around Montana for the last 8 months, including a trip in Late July to Forest Grove, OR (2010 Willamena Dr Area, Jon and Julie Titus)
7. They have been tasking while behind bars in Missoula and Ravalli Counties.
